1.0 The Author(s) [hereafter, "Owner(s)"] hereby irrevocably transfers and assigns to AMPP and its successors and assigns all title and interest, worldwide, in and to the Work named above, including without limitation, any and all intangible rights, all statutory or common law copyrights, and all moral rights, effective when the Work is accepted in any form.
