I represent StLPNP's on the Missouri Council on Advanced Practice (MOCAP). This is an organization of Missouri Advanced Practice Registered Nurses that operates as an organizational unit within the formal structure of the Missouri Nurses Association. It brings together representatives from APRN groups from across the state to nurture. enhance and promote the role of the **Advance Practice** Registered Nurses. We meet quarterly.

The legislative agenda for 2012 has decided to move forward to expand the scope of practice for APRN's in the state of Missouri for full plenary authority. Our goal is to provide "Barrier Free Care" to Missouri Citizens by advanced practice nurses. To achieve this goal we need to change the Missouri State law. We need your help. I sent out an email earlier with a power point presentation from MONA to familiarize you with the legislative process. Please review this power point presentation. Also, I am asking each one of you to identify your **Missouri State House Representative** and **Missouri State Senator**. We will soon be asking you to write letters, send an email, visit or ask one of these legislators to sponsor or support this legislation. We want you to identify those legislators now, so you will be prepared when we ask for your help. Please help us support you.

The doctoral APRN students are currently meeting with the legislators in Jefferson City to educate them about Advance Practice Nurses. On October 15, we will be meeting at the capital in Jefferson City for Missouri Nurses Association APRN-SIG "Lobby Day at the Capitol".

It is more important now to remember MONA is your voice in the Missouri legislation. Increasing membership is key for MONA to continue to drive our vision, mission, and power. The dues to MONA support this voice and those that work to have your voice heard. To be a MONA member it costs a new member \$177.75 per year or \$15.31 per month. A renewal membership costs \$214.25 per year or \$18.35 per month. Please try to support those who support not only APRN's but all Missouri Nurses. You can join by going to www.missourinurses.org and registering online.

Update on prescriptive privileges for controlled substances. It will be October 1st, 2011 before the database and rule process are complete. There were a few minor corrections that needed to be made in the rules. The Board of Nursing will be notifying APRNs when they are eligible to apply for a BNDD & DEA number.

Missouri has been selected as an Action Coalition by the Future of Nursing: Campaign for Action (CFA), a collaboration created by the Robert Wood Johnson Foundation and the AARP Foundation to implement solutions to the challenges facing the nursing profession, and to build upon nurse-based approaches to improving quality and transforming the way Americans receive health care. To turn growing momentum and nationwide interest in the health care workforce into action, the Action Coalitions have been convened to advance key issues at the local, state and national levels. The Missouri Action Coalition, which includes co-leads Missouri Nurses Association, Missouri League for Nursing, and Missouri Health Advocacy Alliance, will work with CFA to implement the recommendations of the Institute of Medicine report, The Future of Nursing: Leading Change, Advancing Health. Action Coalitions function as the campaign's field operation. Their mission is focused on fostering interprofessional collaboration, the ability of all health care professionals to practice to the full extent of their education and training, strengthened nurse education and training and the increased participation of nurses as leaders.

# STLPNP SURVEY MONKEY RESULTS

In October we requested all members take an 18 question survey about their employment and preferences for future StLPNP meetings. We received 55 responses (33% return rate). The "most common" PNP is a 30-39 year old with an MSN and certified by the PNCB. They have 11-20 years experience as an RN yet less than 3 years as a PNP. They have worked less than 5 years in their one position in St. Louis City. They practice full time in a private practice specialty care setting. Their salary is \$83,220.80- \$93,600 (\$40.01- 45/ hr). Clinical practice in primary care versus specialty care was almost evenly split among the responses at 42.3% and 57.7% respectively. The salary ranges of the respondents was \$30.01/hr (\$62,420.80/ yr)-\$50/hr (\$104,000), with 28.3% responding in the range of \$40.01/hr (\$83,220.80/yr)-\$45/hr (\$93,600). Higher salary potential was seen with experience as well as in specialty care and within St. Louis City and Metro areas.
