# PRESIDENT'S CORNER



# FROM THE LEGISLATIVE CORNER

The NC General Assembly convened for the regular or "long session" in January. We currently have 4 nurses serving in the General Assembly: Rep. Carla Cunningham, Rep. Donna White, Rep. Diane Wheatley, and Sen. Gale Adcock. While there are numerous bills relating to healthcare, the one most frequently asked about is what was previously known as the SAVE act. It has been rebranded to "HB 514/SB 537 - APRN Definitions" or the APRN Full Practice Authority bill (there is now a federal SAVE act that has nothing to do with full practice authority, this was done to prevent confusion). A separate amendment to bill SB 345 (which was previously unrelated to APRNs—many times amendments are added to completely unrelated bills in hopes of passing the amendment) moves the oversight of NPs and CNMs solely under the Board of Nursing (and removes the Board of Medicine oversight) This bill has been passed in the Senate, which is great news and a good step forward.

The Full Practice Authority bill has long been supported in the Senate and also has a lot of support on the House side but has previously not been allowed out of committee, which means the full House cannot vote on it.

What can we do as NPs? Some suggestions:

**Tuesdays at the Legislature:** Difficulty timing as it occurs from 10a-12p on Tuesdays. The reason for Tuesdays is that is when the majority of the General Assembly members will be in Raleigh in their offices. **Send a message to your legislator!** You can look them up here: https://www.ncleg.gov/FindYourLegislators. If they are a sponsor of the bill, thank them for sponsoring it. Personal stories work! Especially those of you who own your own practice or are paying a collaborating physician. Remember that legislators are regular citizens who may not know a whole lot about the health care system and the awesome care we give our patients and our roles as collaborative members of a healthcare team.

Here is some sample messaging from NCNA (personalize it and use it!):

"Passing the APRN Full Practice Authority bill (H 537/S 514), introduced with 65 bipartisan co-sponsors, will modernize regulations for Nurse Practitioners, Certified Nurse Midwives, Certified Registered Nurse Anesthetists, and Clinical Nurse Specialists, making North Carolina the 28th state to do so. Now is the time for NCNA members and North Carolina nurses to make their voices heard and urge their legislators to support the bill and pass it – once and for all."
