# Operation Dry Water 2015 Results Law enforcement in all states & territories conduct heightened boating under the influence enforcement

In an effort to increase public awareness about boating under the influence and remove impaired operators from our nation's waterways, the <u>National Association of State</u> <u>Boating Law Administrators</u>, in partnership with the U.S. Coast Guard and hundreds of local, state and federal law enforcement agencies, conducted the seventh annual <u>Operation Dry Water campaign June 26-28, 2015</u>.

The Operation Dry Water campaign coordinates on a national level the saturation of thousands of law enforcement officers on the water before the Fourth of July Weekend with the mission of spreading awareness about the dangers of boating under the influence and to facilitate heightened BUI enforcement just before a holiday known for drinking, boating, and fatal accidents.

Through the work of the Operation Dry Water campaign and the year-round efforts of participating agencies, thousands of recreational boaters are being contacted and educated at the local level. In addition, hundreds of impaired operators are removed from the waterways during Operation Dry Water heightened enforcement weekend each year.

In 2015, 582 local, state and federal agencies joined forces in every U.S. state and territory for the Operation Dry Water campaign. Law enforcement was out in force across the country keeping the waters safe by simultaneously identifying and removing hundreds of impaired boaters from the waterways and educating recreational boaters one on one.

Over the course of the Operation Dry Water weekend 6,605 officers:

- Made 278 BUI arrests for both drugs and alcohol
- Issued 17,942 citations and safety warnings
- Made 57,402 vessel contacts
- Contacted 125.087 boaters
