Needs Statement: Supporting UCOTVA is essential in making changes to positively influence consumer safety by creating consistency among states in regard to titling and identifying vessels that have been deemed unsafe and preventing them from being sold without disclosure. Internet sales and sales that are organized by the overseas builder are NOT considered as a self-importer. By creating an affidavit for a person registering a boat as a "self-import," the state will have some Backing in enforcing self-import regulations.
