#### NASBLA Paddlesports Committee Charter

#### Paddlesports Vision Statement

NASBLA's Paddlesports Committee provides a venue for a diverse group of stakeholders to engage with NASBLA members in productive dialogue to find actionable opportunities to partner and promote paddlesports while growing a culture of safety across the United States so that over time the incidence of accident and injuries declines even while participation increases. The Committee strives to develop recommendations and work products to the NASBLA membership based on the best data available and professional judgment of its diverse members.

#### Program recommendations will:

- Advance the strategic plans of the National Recreational Boating Safety Program and NASBLA;
- Incorporate best practices and current research;
- Seek to mitigate risk factors, to grow a culture of paddling safety;
- Assure that the paddlesports community has the tools, information and messaging to reduce incidents, injuries and fatalities; and
- Connect the public, member organizations, and stakeholders with the products of the committee and others.

Paddlesports Committee members are assembled into project teams, taking the lead on specific, assigned charges and monitoring activities.

#### 2023-24 Annual Paddlesports Committee Meeting

The Paddlesports Committee leadership has met several times, since November 29, 2023, and the full Committee has convened three times. These meetings focused on drafting the 2023-2024 draft Charge language to present to the Executive Board for consideration and approval.

On January 16, 2024, the Paddlesports Committee finalized the proposed Charge language, which has been submitted to the Executive Board for consideration and approval. The Paddlesports Committee is waiting for the Executive Board's input and decision about the proposed Charges before scheduling any meetings and moving forward with any Charges.

The Committee held an in-person meeting on March 14, 2024, in Lexington, KY in conjunction with the RBS Meeting. The Paddle sport Committee roster is provided in Appendix A and a copy of the full meeting agenda is provided in *Appendix B: 2024 Paddlesports Committee In-Person Meeting Agenda*.

This report provides a summary of committee deliverables and work products for the 2023-2024 Committee year.

#### PADDLE 2023-1 Data & Trends

Conduct a in depth study of each reportable, human powered watercraft fatality between 2021-2022 to determine if there are any trends with brands, models, sizes of the vessels, and life jacket use while the accident occurred. Use this study and other data trends for NASBLA to potentially advocate for an amendment in the 2025 reauthorization to the trust fund that includes an excise tax on kayaks, canoes, SUP's, paddles, and life jackets. (Revised, carryover) (NASBLA 2.1, 2.5)

**Needs Statement:** Paddlecraft activities are growing in popularity across the country, including in the area of sport fishing. We know little about these recreationalists, their decisions, current contributions to the Sport Fish Restoration and Boating Safety Trust Fund (Trust Fund), water awareness and education, and their public water access needs. We do know State agencies' safety response requests to these recreationalists are increasing as is the demand for more and differing types of public access sites among different recreationalists, in different locations, and for a variety of uses. The states are managing a growing number of paddlecraft users while demands for various types of public access is increasing, safety issues are growing, and states have insufficient information to inform their actions to best meet the needs of the public.

**Measure of Effectiveness:** A comprehensive, qualitative, and quantitative, paddlesports indepth study of each reportable, human powered watercraft fatalities (2021). This data can be used as a statistical summary, behavior analysis, and increased awareness of waterway management for State Program use. Use this study and other data trends for NASBLA to potentially advocate for an amendment in the 2025 reauthorization to the trust fund that includes an excise tax on kayaks, canoes, SUP's, paddles, and life jackets.

**Deliverable(s):** The Charge will identify and report the extent of critical information that is incomplete or missing from fatal paddling incidents reported in BARD. The purpose of this charge was to analyze the accuracy of boating incident reporting. Reporting can assist in making important educational, law enforcement, and legislative decisions about paddling safety. However, it has become clear that accurate data is not always available to understand or identify paddling safety issues. This Charge aims to identify and report the critical information that is incomplete or missing in BARD so that the system can be improved.

The Charge team met several times to review and discuss the reportable boating fatality accidents for human powered watercraft as listed in the 2022 and 2023 BARD reports. For the purposes of this report, human powered vessels were identified as canoes, kayaks, SUPs, rowboats, and inflatables. Issues with reporting were found to be in some of the critical data fields, such as vessel type, manufacturer, PDF wear/carriage requirements, and operator education and experience. These findings include incomplete, insufficient, or unknown answers in the data fields below. Findings of work completed this cycle, were from a total of 343 human

powered vessel reports (fatalities) for the 2022 and 2023 BARD Reports are as follows:

- 1. <u>Type of vessel</u>: There were 36 entries where the type of vessel was listed as inflatable. The charge is concerned that this may not be correctly identifying the vessel. There are many types of inflatable such as kayaks, SUPs, and rafts. Listing inflatable in hull material as opposed to type of craft may be better suited for reporting purposes. Also, the reporting for whether the vessel was privately owned or rented was incomplete as 86 incidents were listed as unknown or left blank.
- 2. <u>Manufacturer</u>: Identifying the correct manufacturer, model, and HIN are crucial in being able to identify any trends with specific boat manufacturers and models.
  - For the manufacturer field, 115 reports were listed as unknown or left blank.
  - For model, 183 reports were listed unknown or left blank.
  - For HINS, 32 were listed unknown or left blank.
- 3. <u>PFD Worn/Carriage Requirements/Inflatable PFDS</u>: Some numbers that stood out to committee were as follows:
  - Of the 343 fatalities, 270 (79%) were men.
  - 237 reports were victims not wearing a PDF and 36 reporting fields for PDF worn were left blank. That is a likely percentage 79% of victims were not wearing PFDs.
  - Drowning was the cause of death in 288 (84%) of the victims.

The Charge Team found these items that could be improved upon:

- Concerns were brought up regarding PDF wear and inflatable PDFs, how many of the reports were the victims wearing inflatable PDFs and if so, were they being worn correctly? Did the inflatable work as it was supposed to?
- Crucial data for follow up on in the reports is to determine if a PDF was worn or not. 36 fields for PDF worn were left blank.
- PFDs on board was left blank in 242 (70%) of the incident reports. State and
  Federal carriage requirement laws require PFDs carried for each person on board
  the vessel. Having more complete information in this field can help determine
  the effectiveness of these laws and whether or not the victims had PDFs
  available at the time of the incident.
- 4. Operator Experience/Education: Operator experience was listed as unknown or left blank in 205 fields. Operator education was listed as unknown or left blank in 216 fields. When you combine these unknown factors with operators that had no experience or no education, the number climbs to 333 (97%) of all incidents reported. The Charge realizes that obtaining this information may be challenging. However, obtaining this information is critical in analyzing the data and impact of paddling education and

experience.

**Recommendation**: The Charge has completed its task as identified in the charge proposals form for 2023-24.

#### **PADDLE 2023-2 Microlearning and Outreach Needs Assessment**

Develop microlearning training and resources to help facilitate opportunities for officers, educators and administrators to engage the paddling community. (NASBLA 2.6) (RBS Initiative 1)

**Needs Statement:** Officers, educators and administrators need new and innovative strategies to help facilitate opportunities to engage the paddling community. Microlearning components can quickly give these professionals the information and tools they need to engage this growing boating community effectively. A needs assessment will identify gaps where additional resources may be needed.

**Measure of Effectiveness:** There is no inventory of currently available materials; efforts to create materials are often unnecessarily duplicated. This Charge will survey state BLAs and educators to identify what digital and print materials states have that can be shared among the boating education community and identify any gaps in boating education materials. This list of gaps could inspire states and our associate members when creating new content that is desired and beneficial to the boating education community.

**Deliverable(s):** Several meetings were held throughout the year to develop a short survey to be sent out to the State Educators.

The survey was designed to determine the following:

- What are a State's "go to" materials for paddlesports education?
- What materials do States have to promote paddlesports safety and in what formats (digital, printed, social media)?
- What paddlesports information do States need for their educational programs?
  - o In what format is this information needed?
- What length of a video is best for your program?

#### Survey results showed:

- Very little material is available to share among members.
- We need more information or updated information on:
  - o the importance of wearing PFDs,
  - o orientation to paddling,
  - o importance of float plans,
  - dealing with flooding conditions,
  - o paddling basics,
  - reboarding kayaks,
  - o required paddlesports equipment,
  - o laws,
  - o etiquette,
  - o matching skills to venue,
  - o kayak fishing, and
  - dangerous river conditions

**Next cycle recommendation:** We recommend this charge be continued. We need to again reach out to educators to return the survey to confirm where gaps exist, and to identify what efforts should be made to recommend a list of acceptable and available safety videos for use by boating educators.

#### PADDLE 2023-3 Outreach to Paddlecraft Liveries & Retailers Best Practices

Create a program for paddlesports manufacturers, retailers, and liveries that will recognize their efforts that help to create and promote a safe paddling culture. This program will be similar to the Seal of Safe Boating. The Committee will identify and develop specific award criteria for paddlesports manufacturers, retailers, and liveries. These criteria will consider the methods and efforts already used to create a culture of paddling safety. It will also determine an appropriate amount of time for which the honor is valid and an effective method to distribute the honor.

(NASBLA 1.1, 1.4, 1.5, 2.1, 2.2, 2.3, 2.5,2.6) (RBS Initiative 1: CoA 1, CoA 2, CoA 3, Initiative 3)

**Needs Statement:** Paddlecraft rental liveries are one of the prime outlets to engage entry level, non-motorized boaters in safety awareness and risk mitigation for increased safe participation. Developing best practices for state boating safety professionals to use offers an opportunity to engage retailers and livery operators and further boating safety messages for this hard-to-reach population.

**Measure of Effectiveness:** A program for paddlesports manufacturers, retailers, and liveries that recognize their efforts that help to create and promote a safe paddling culture. Grow the amount of National Paddlesports Committee Honors (NPCH) awarded in the future.

**Deliverables:** The objective of this charge was to continue to develop the National Paddlesports Committee Honors (NPCH) and launch the application in time to receive and review applications from interested businesses prior to the award period which the committee decided would be in the fall 2024. The committee finalized the language for the application at the committee meeting in Lexington and voted to approve the application for submission to the NASBLA Executive Board. Due to a procedural disagreement, the application was unfortunately not submitted to the Executive Board for their April meeting as the committee had voted to do. This pushed the timeline back too far to be able to launch the application, recruit applicants, and have a review period in time for the 2024 honors to be awarded.

**Next cycle recommendation:** This charge should continue to be worked on and developed in the 2025 committee cycle. It has the potential to decrease unsafe behaviors shown through social media and increase the number of life jacket shown being worn through photos posted by brands with large followings. Charge members will resume working deliverables following the annual conference to allow sufficient time for Executive Board review of materials, and applicant review.

#### **PADDLE 2023-4 Paddling Course & Instructor Charge Proposal**

State Basic Paddling Course Needs Assessment: Conduct a needs assessment to determine the demand for creating a comprehensive entry-level paddling program and a simplified instructor program tailored for state boating educators to efficiently deliver essential (lifesaving) paddling information at short-duration public and outreach programs.

**Needs Statement** – With the growth of paddlesports activities and the increase in related incidents and fatalities, many state boating agencies are developing and engaging the often difficult to reach paddling demographic through short-duration events. Many state boating educators face challenges when organizing entry-level paddling events or participating in brief public outreach activities. The needs assessment was conducted to help understand the issue.

**Measure of Effectiveness:** The effectiveness of this charge will be based on the number of states that would implement (in whole or in part) the resulting products into their education program.

**Deliverable(s):** The survey was designed to determine how many state agencies have or need an introductory paddlesports program. Survey questions addressed the current program offered, desired length of program, delivery approach, content, needed support materials, instructor credentials, and whether a NASBLA-developed paddlesports program was desired. The survey was distributed on March 5, 2024, to BLAs and Education Coordinators via BLA Brief and the NASBLA Education Coordinators list.

There were 47 responses from 31 different states complied and analyzed before the Paddlesports Committee met in Lexington, KY on March 14<sup>th</sup>. The results constitute a scientifically valid survey with a good representation of the wants and needs of the NASBLA state agency membership. All survey information was shared on Basecamp.

One of the most telling questions was question #3 which says: *Please indicate your state's level of support for this statement: It is important for the NASBLA Paddlesports Committee to develop or recommend an introductory Paddlesports program for state educators/ staff/ volunteers.* 

RESULT: 87% agreed or strongly agreed with that statement.

Other Summary findings are as follows:

- 1. **Need:** There is a need for a paddlesports program to be used by the states (55% don't have a program and another 15% are using someone else's program).
- 2. **Recommended Program Length:** 1-4 hours or half-day maximum (84% of respondents support this with 66% recommending 3-4 hours- 1/2 day). Anything over one day is NOT appealing to the states offering a paddlesports program with 0.0% support for this longer format.
- 3. **Desired Resources:** Instructor's Manual (88%) and/or Student Manual (74%) were the two highest-ranked items needed to conduct a program.
- 4. **Location:** An on-water component is desired (91% agree with 45% strongly agreeing) to supplement a classroom, onshore, or online program.
- 5. **Credential:** Some type of instructor certification is desired (59% agree; 27% were neutral or not sure).

After review, the committee determined that the original charge was complete and voted to submit a request to the Executive Board to modify the original charge to include developing a curriculum and tools for an introductory paddling program that meets ANSI standards. Steps would include:

- 1. Examine existing programs that would possibly fulfill state agency needs or develop a NASBLA Program. (Note: There are a couple of states which have developed their own programs that may address this need.)
- 2. Consider options for program administration of a voluntary not mandated paddlesports program. (Note: There is strong support that the selected program should be one that is administrated by NASBLA or the state directly so that states may implement the program without barriers and cost from other entities.)
- 3. It is requested that the committee continue considering the results of the survey to best address state agency needs, such as a desire to meet America National Standards for human-propelled basic boating knowledge and on-water skills and to have a simplified instructor program.

The Executive Board voiced approval of this recommendation.

The charge team then moved forward with to identify a simplified instructor program, first identifying standardized criteria that follows the American National Standard for an entry level paddler. A draft document has been created to address common mishaps by an entry-level paddler. The draft document includes an on-water component in response to the survey results and provides guidance for a presenter to safely conduct an on-water activity. Once completed, the on-water guide will have separate information for the three major paddlesports craft: kayak, canoe and Standup Paddleboard (SUP). Still to be determined is a training/credentialing process for on-water instruction.

**Next cycle recommendation:** Continue to move forward with development of a paddlesports presenter's guide for state boating educators. Develop/recommend a process to voluntarily train state educators wishing to receive a NASBLA paddlesports training credential to provide

entry-level paddlesports training based on American National Standards for human-propelled boating. Charge members will resume work on deliverables after the annual conference.

#### **National Paddlesports Committee Honors Application**

The National Association of State Boating Law Administrators (NASBLA) Paddlesports Committee developed the National Paddlesports Committee Honors in 2023 to recognize and celebrate the paddling community for their commitment to adhering to the highest standards in promoting safe paddling practices. The Paddlesports Committee acknowledges the importance of providing recognition and endorsement for companies and organizations prioritizing paddling safety through their social media, website, printed advertising and publications, videos, public events and trainings, and products.

The NPCH will not be considered a certification. However, it will provide recognition that the company or organization is deemed, by the Paddlesports Committee, to be beneficial to the paddling community due to sufficient representation and promotion of safe paddling practices. This application will be open starting January 1, 2024 – August 1, 2024.

Members of the Paddlesports Committee will review and judge the entries in non-competing categories. Three judges will be assigned by the Committee Chair to review each applicant. The honors recipient(s) will be posted on the NASBLA website and recipients will receive an electronic copy of the NPCH logo for their websites and social media. The NPCH will last for one year; companies who wish to continue displaying the logo will have to reapply each year. The honors will be formally presented at a boating safety or paddlesports event during the application year.

The evaluation categories the judges will be using for this honor are Social Media and Website. However, more evaluation categories will be considered for future application cycles. To be considered for the NPCH, at least 15% of content from the past year must be specifically about paddling activities or products in each area of review. All content going back one year from the application date will be evaluated.

The evaluation process and awarding of the NPCH are at the sole discretion of the Paddlesports Committee and the assigned judges. While social media and website are the primary categories for evaluation, other aspects may affect whether the NPCH is awarded. This program is new and evolving; please ensure you have the latest version of the criteria before applying. Additionally, if anything comes to the attention of the Paddlesports Committee after an application is submitted that would disqualify an applicant from formally receiving the NPCH, the committee may revoke the honors, even if the application has already been evaluated.

#### **Criteria for the National Paddlesports Committee Honors:**

The following are the criteria the judges will be using to evaluate applications for the NPCH. Criteria will be judged using number gradients, with 0 being the lowest and 10 being the highest.

- In photos and videos posted on the company's website or social media, all paddlers are shown wearing properly fitted and fastened life jackets (appropriate for the activity) when on the water.
  - To receive a score of 10, every photo and video on the social media account or website must be in compliance (or contain an appropriate safety focused disclaimer), including photos from photo contests, in stories and highlights, or other consumer/follower generated content shared. Every photo or video showing a paddler (or paddlers) without a life jacket (and without an appropriate safety focused disclaimer) may drop the score further.
- Paddlers are shown using or carrying appropriate safety equipment. When visible, all
  items are shown in optimal condition and being used properly based on the
  environment and activity (i.e. helmets, dry suits/wetsuits, appropriate SUP leashes,
  throw bags, communication devices, lights when legally required, etc.).
- Paddlers are shown using paddlecraft in the appropriate manner as designed by the manufacturer (boats aren't overloaded, etc.).
- Social media posts (or website content) encourage sober paddling and do not show or display the use of alcohol, cannabis products, or other products that may impair a paddler while paddlers are actively engaged in paddling activities.
  - Any visual content showing (or written content describing) the use of alcohol, cannabis products, or other products that may impair a paddler while actively engaged in paddling activities will result in a score of 0 (the lowest score) for this section.
  - If no content shows this behavior, the score may be neutral (5), and each instance of encouraging sober paddling may raise the score from there.
- The company encourages paddlers to enhance their skills by taking a safety class or training.
  - If there is no content on the company's social media accounts (or website) encouraging followers to take a paddling safety class or training to enhance skills, the lowest score may be given in this category.
  - Content providing safety tips or education or encouraging paddlers to get additional education or training may raise the score for this category.

- The company promotes safe boating practices on social media during major national campaigns, such as National Safe Boating Week or Operation Dry Water.
  - Companies that do not post about safety during major national campaigns (like National Safe Boating Week) will not have this category count against their overall score. However, if a company does have posts about these campaigns on their social media, they will receive points towards their total score. (This is subject to change in the coming years).


