## **Conference Evaluation and Certificate Printing Procedures:**

Conference Evaluations are on-line through Express Evaluations. On or about October 26th, you received an email from Express Evaluations with the username and password needed to gain access to the evaluation site. The link to the evaluation site is on the TSNO website <a href="https://www.txsno.org/continuingeducation/tsnoconference">www.txsno.org/continuingeducation/tsnoconference</a> along with directions for filling out evaluations and printing your conference certificate.

To earn credit and get your Conference Certificate, you must evaluate each concurrent and general session you attend, <u>and</u> complete the overall conference evaluation (not including Nursing Jurisprudence) through the online process. You may evaluate Friday Concurrent Session evaluations upon completion, but you will not receive credit for them until attendance validation by the conference registrar has been completed, on Saturday.

Certificates cannot be printed until Wednesday, Nov. 9, 2016, once all attendance has been verified by the conference registrar.

<u>Friday Concurrent Sessions</u> - credit is verified solely by the sign-in sheets for each session, **it is your responsibility to sign in at every Friday concurrent session**.

<u>General Sessions</u> - you will need the attendance code provided in each session in order to complete it's online evaluation. Use the spaces on the charts above to record those codes. Codes will **NOT** be available outside of the sessions.

Friday Nov 4th - Nursing Jurisprudence & Ethics: This session, offered by the Texas Department of State Health Services, requires participants to sign in at the beginning of the Nursing Jurisprudence & Ethics session. Sign-in sheets, grouped alphabetically, will be available. If your name is not already on the sign in sheet, you may add your information in one of the blank spaces provided. You MUST sign-in and complete ALL requested information to receive credit for this session. Sign-in sheets will be collected at the 10-minute mark of the presentation. No credit is available for those arriving after the sign-in sheets have been collected. Certificates for Nursing Jurisprudence will be emailed directly from the Texas Department of State Health Services, the CNE provider for this session.
