Objectives:

- To recognize organizations or individuals who have continually supported or uniquely contributed to SCASN, school nursing or school health services in at least the last five years.
- 2) To recognize an individual who has given outstanding service to SCASN/NASN within the last 5 years.

Award Criteria:

- The proposed candidate must meet one of the listed objectives.
- Data substantiating objectives must accompany the nomination of the candidate.
 - Example: Descriptions
 - (1) Outstanding services to SCASN, special project(s), programs for school nursing/child health,
 - (2) Describe how SCASN benefited.
- Officers, Board of Directors, and SCASN members will be asked to submit candidates.
- Current Executive Committee members are not eligible to receive an award.
- The Distinguished Service and Corporate Recognition awards are limited to the selection of one candidate in each category to appropriately recognize the exemplary contributions the award focuses on.

Awards Selection Criteria:

- The individual's life and contributions to SCASN could inspire others to promote the health of schoolchildren.
- The individual shall also promote the goals and philosophy of SCASN.
