

Consultant Team Staff Changes

On July 11th Elizabeth Shook filled the previously vacant West Region Consultant position. Elizabeth (Beth) comes to us from Avery County. During this interim period those seeking assistance should continue to contact their assigned consultant team member who has been providing coverage.

A new team position was added this summer – School Health Chronic Disease Nurse Consultant. That position has been filled by Donna Daughtry who recently retired as the Wake County School Health Program Manager. The position is funded through a CDC grant that includes working with school districts on helping students manage chronic health issues.

We sadly say goodbye to Sonya Dunn on August 24th, the Central Region Consultant. Sonya has accepted an exciting opportunity as the State Health Plan Nurse Consultant with the NC Department of the State Treasurer. We will miss her but wish her the best. 35th Annual School Nurse Conference-21st Century School Nursing: Evidence, Outcomes and Standards The conference will be held at the Joseph S. Koury Convention Center in Greensboro on Dec 6& 7, 2018

School Nurse Orientation Modules The target audience for this online course includes all new school nurses who have not taken School Nurse Roles and Responsibilities and is a required component for School Nurse Funding Initiative (SNFI) and Program 351 school nurse orientation. The orientation course is an introduction and prerequisite to future offerings of School Nurse Roles and Responsibilities. To register please contact your Regional School Health Consultant. 5.0 contact hours will be awarded upon completion of all modules.

Annual -Health-Assessment-Report-and-Immunization-Report. For ease of completion, the immunization and health assessment reports are once again combined. The delayed report closure date is included in the September 25th Order of the State Health Director regarding the temporary suspension of immunization school entry requirements from September 21 until November 1, 2018.

Health Assessment and Immunization Special Circumstances Students who are homeless or considered displaced for a variety of reasons such as natural disasters, turmoil in another country, or inadequate family finances, should not be held subject to the school entry requirements for Immunization or Health Assessment compliance. Please keep in mind that the above circumstances serve as examples although there is no official list that qualifies a student or family as homeless. Information regarding homelessness can be found on the DPI Homeless Program webpage or from your local school district Homeless Liaison. Students who are facing such situations, and thus initially exempt from rules, should receive services that will connect them with an area provider and enable them to receive needed services and/or records in a timely manner as fits the situation.

Epinephrine Auto-Injector Programs

This is the annual reminder that the training for § 115C-375.2A. School supply of epinephrine auto-injectors is required to include annual re-training. These requirements are applicable to both charter and LEA schools. In addition, the expiration dates for the injectors should be noted. The FDA has provided some guidance on extended expiration dates for some dose lots in response to the current shortage. The Food Allergy Research & Education's (FARE) emergency care plan has been revised to include patient instructions for epinephrine auto-injectors.
