Legislative News

The night with the legislature(reception) was well attended both by nurses and legislators. Our executive board spent their time educating members of the school nurse role and need to follow up with the recommendations of the legislative study about school nurses.

The day following the reception, members of the executive board and other SNANC members visited their representative and other key legislators to continue the discussion. The group started the morning with a briefing from NCNA and our lobbyist. Bills that we need to monitor: House Bill 74 and 76 regarding school safety. We have verbal information that the Governor's budget does include monies for additional school nurses We have verbal information that the DPI budget request is for additional school support personnel that would include school nurses, but we are unsure how these while remaining in touch with the funds would be distributed. There is not a specific bill addressing the school nurse funding based on the legislative study.
