Event Data Disclosure Agreement

I. Acceptance of Terms

It is important that you read all terms and conditions carefully as by registering for, attending, and/or utilizing event services, you agree to the collection, use, and sharing of your personal data for the purpose of your participation in this event.

II. The Data NASTD Collects

Registration

By registering for this event, you, as an “attendee”, are providing to the National Association of State Technology Directors (“NASTD”) certain personal data that allows NASTD to serve you better. NASTD collects the following types of personal data (“Data”):

- Organization
- Job Title
- Address
- Email
- Phone
- Dietary Needs

The collection of this data is to provide you with services as it relates to your attendance at this event. Without this data, NASTD will be unable to guarantee the provision of said services.

III. How and Where NASTD Collects the Data

NASTD collects your data when you register for this event through the NASTD event registration website. You agree that the data you provide during the registration process is accurate, true, and complete. You have the right and responsibility to update any incorrect or out of date data in a timely manner. Provision of erroneous data may result in the failure to receive important updates and information about the event. You may update your registration by contacting NASTD at nastd@csg.org.

NASTD uses CrowdCompass in the facilitation of this event. This mobile application is provided to attendees to enhance the event experience and provide a mechanism by which important event information can be easily accessed. By downloading and utilizing CrowdCompass the attendee agrees to the terms and conditions of the application independently of this agreement and is solely responsible for all personal data provided and shared through the application.

Payment

Electronic payment for event registration is taken and managed in Cvent. Sponsorship payment is taken via Wufoo and processed by Authorize.net. By providing payment information through those third parties, attendee agrees to the terms and conditions of the applications independently of this Agreement and is solely responsible for all personal information and data provided and shared through those applications.

Attendance

During the event, it may be necessary for attendees to verify their personal data provided during registration as it relates to event attendance. This personal data is for the sole purpose of verification of previously collected data to confirm your identity, accommodations, and delivery of services at the event. Failure to provide this data during attendance may result in the inability to render services to the attendee.

Additionally, this event provides opportunities for networking with other attendees. Personal data shared directly with other attendees during networking is the sole responsibility of the attendee. Attendees should exercise sound judgement concerning sharing of personal data with others and should take necessary steps to ensure privacy and protection of said data as NASTD shall not be responsible for data shared in this capacity during the event.

IV. How NASTD Uses Your Data

V. How NASTD Shares Your Data

action regarding suspected ethics violations, actual illegal activities, or to assist government enforcement agencies; 2.) enforce our agreement with you; 3.) investigate and defend ourselves against any third-party claims or allegations; 4.) protect the security or integrity of our services; 5.) exercise the rights and safety of NASTD, you, personnel or others. We will attempt to notify you about any legal demands for personal data when appropriate in our judgement, unless prohibited by a court of law or court order or when the request is an emergency.

VI. Data Storage

You agree that NASTD will retain the personal data provided and maintain accurate records of this event in addition to the provision of services. All data is retained and stored in perpetuity for historic record of this event. You have the right to request that your personal data be deleted or a portion thereof; however, NASTD will retain data, which is reasonably necessary to meet accreditation standards, meet regulatory requirements, resolve disputes, maintain security, prevent fraud, or abuse, or enforce this agreement.
