## **Exhibitor Rules & Regulations**

- Exhibitor space must be fully paid and will not be processed or assigned without the required payment.
- Exhibitors may not assign, sublet, or share their exhibit space with another business, company, or organization. Exhibitors must show goods/services manufactured or dealt by them in the regular course of business.
- Exhibitor shall have sole responsibility for ensuring that their exhibit is in full compliance with the Americans with Disabilities Act and any regulations implemented by that Act.
- ▶ Should the Convention be cancelled, postponed, or abandoned, the limit of claim for damages and/or compensation by the Exhibitor shall be the return of the amount already paid for the space for this specific event. Should the Convention be curtailed or abandoned in part, the limit of claim for damages and/or compensation by the Exhibitor shall be the return of the prorated amount the Exhibitor already paid for space for the cancelled portion of this specific event. The Exhibitor will be returned the amount paid if the Convention is cancelled, postponed, curtailed or abandoned due to acts of God, war, acts of terrorism, government regulations, disaster, strikes, labor disputes, civil disaster, or curtailment of transportation facilities.
- Exhibitor agrees that her/his exhibit space shall be admitted into the Convention and shall remain from day to day solely in strict compliance with all the rules herein described. The National Employment Lawyers Association (NELA) reserves the right to reject, eject, or prohibit in whole or in part any Exhibitor with just cause, at NELA's discretion. If an Exhibitor is ejected, no return of exhibitor fee shall be made.
- ▶ Exhibitor agrees to the "Exhibit Hours" as specified by NELA and may not hold its exhibit open beyond the specified hours or in another location than assigned.
- ▶ NELA's assignment of exhibit space is final and shall constitute an acceptance of Exhibitor's offer to occupy space. After assignment, space location may not be changed, transferred, or cancelled. Notwithstanding the aforementioned, NELA reserves the right to change location assignments at any time in its sole discretion.
- Exhibitor fee includes one 6' table top exhibit space and one (1) complimentary registration to the Convention. Only one company/ organization name per exhibit space. No signs or advertising devices shall be displayed outside the exhibit space other than those furnished by NELA. Exhibitor is responsible for any audiovisual, Internet, telephone, delivery, labor, and any other charges associated with the exhibit. All demonstrations, sales activities, and distribution of circulars and promotional material must be confined to the limits of the Exhibitor's assigned space. Exhibitors must not place equipment for display or demonstration in such manner as to cause observers to obstruct passageways. All equipment for display or demonstration must be placed within the assigned exhibitor area.

- ▶ NELA provides its Exhibitors with three (3) lists of Convention participants. At the Exhibitor's request, one list of Convention pre-registrants will be sent on June 9, 2017 to registered Exhibitors for the express purpose of announcing the organization's/ company's attendance as an Exhibitor at this Convention. A sample copy of the mailing must be sent to NELA for approval before NELA provides you with the pre-registrant list. Another list of participants is included in the Convention registration packet, this list is for reference only and may not be used in any form by Exhibitors without the express permission of NELA. A third list of all Convention participants is provided after the Convention for one-time use only. A sample copy of the mailing must be sent to NELA for approval before NELA provides you the list of all Convention participants. Any request for the list of all Convention attendees must be made by August 31, 20176. None of these list is to be sold or traded to any other entity, nor are they to be used for fundraising purposes. Email addresses will not be provided for the above purposes. Any electronic mail communications to Convention participants using the registration list provided by NELA are strictly prohibited.
- Exhibitors are prohibited from fundraising of any kind or otherwise soliciting funds that are not directly related to the sale of their goods and services.
- ▶ Exhibitors are prohibited from displaying any devices or objects that exceed exhibit space or obstructs neighboring exhibits.
- ▶ Exhibitors or their agents shall not injure or deface any part of the hotel building. When damage occurs, the Exhibitor is liable to the owner of the property.
- ▶ The Exhibitor specifically recognizes and acknowledges that NELA will sustain certain losses if the Exhibitor cancels its exhibit space after it has been assigned and confirmed by NELA. Due to difficulty, if not impossibility of determining said losses, the Exhibitor agrees to pay the following amounts as liquidated damages, and not as a penalty, in the event the Exhibitor cancels all or part of its exhibit space on or within the time periods specified below. All cancellation and/or requests must be made in writing to NELA.

Time Period Liquidated Damages: Cancellation on or before May 12, 2017: 50% of monies paid. Cancellation after May 12, 2017: No Refund.

- All property of the Exhibitor remains under its custody and control in transit to and from the exhibit space, during installation and removal, and while it is within the confines of the exhibit space. NELA is not responsible for the safety of the property of Exhibitors from theft, damage by fire, accident, vandalism, or other causes. The Exhibitor expressly releases NELA from any such loss, damage, or injury.
- NELA shall not be liable for injury of any type from any cause to persons conducting or otherwise participating in the Convention or to invitees, guests, or employees of the Exhibitor.

- ▶ The agreement shall not constitute or be considered to be a partnership, joint venture, or agency relationship between NELA and the Exhibitor. Exhibitor hereby agrees to indemnify, hold harmless, and defend NELA, their respective officers, directors, volunteers, and employees (indemnities) from and against any and all liability, responsibility, loss, damage, cost, or expense of any kind whatsoever as they arise (including but not limited to court costs, interest, and attorney's fees) which the indemnities may occur, suffer, be part of, or be required to pay, incident to or arising directly or indirectly from any intentional or negligent act or omission or breach of these terms, conditions, and rules, or violations of any ordinance or statute by Exhibitor or any of its employees, servants, or agents. The Exhibitor assumes full responsibility and liability for the actions of its agents, employees, and independent contractors, whether acting within or without the scope of their authority, and agrees to indemnify, hold harmless, and defend the indemnities as expenses arise, from responsibility or liability resulting directly or indirectly, or jointly, from other causes which arise because of the acts or omission of its agents, employees, relatives, or independent contractors whether acting within or without the scope of authority.
- Exhibitor hereby assumes entire responsibility and hereby agrees to protect, defend, indemnify, and save Hotel, its owners, its operator, Marriott International, Inc., and each of their respective parents, subsidiaries, affiliates, employees, officers, directors, and agents harmless against all claims, losses, or damages to persons or property, government charges or fines and attorney's fees arising out of or caused by its installation, removal, maintenance, occupancy, or use of the exhibition premises or a part thereof, excluding any such liability caused by the sole gross negligence of Hotel and its employees and agents.

- ▶ Exhibitor shall obtain and keep in force during the term of the installation and use of exhibit premises, policies of Comprehensive General Liability Insurance and Contractual Liability Insurance, insuring and specifically referring to the Contractual liability set forth in this Exhibit, in an amount not less than \$1,000,000.00 Combined Single Limit for personal injury and property damage.
- Hotel, its owners, its operators, and Marriott International, Inc. shall be included in such policies as additional named insureds. In addition, Exhibitor acknowledges that neither Hotel, its owners, its operators, not Marriott International, Inc. maintain insurance covering Exhibitors property and that it is the sole responsibility of Exhibitor to obtain business interruption and property damage insurance insuring any losses by Exhibitor.
- NELA retains the right to make exceptions to the above "Rules and Regulations" as it deems appropriate.
