Helen's 45 years as a nephrology nurse and visionary leadership have significantly impacted the dialysis community. She was instrumental in developing the certification exam for dialysis technicians, having the foresight to understand its value long before it became mandatory. Helen worked as a pediatric administrator of a dialysis program for over 40 years, caring and advocating for children. Her passion for the pediatric population extends outside of her professional work. Each year Helen participates in a children's camp, affording the children she cares for an opportunity they might not otherwise have a chance for fun! Helen has served as a volunteer leader for many organizations and made significant contributions such as chapter writing and review for ANNA publications and developing the pediatric track for the Annual Dialysis Conference.

Helen has been a long-standing member of the Renal Healthcare Association, formerly the National Renal Administrators Association, and previously served on the Board of Directors as a director and as the 2015-2016 President. She co-chaired the Education Council and the Annual Conference Committee for several years.
