Gaps, Concerns Discussed at Oversight Hearing on Dieldrin

Senator Sabrina Matanane asked the few Yigo residents attending a recent oversight hearing on dieldrin to raise their hands if they felt like they'd been properly informed about the contamination that has affected more than 1,000 Guam Waterworks Authority customers in an area of the village. No one raised their hand.

Several officials from GWA, the Guam Environmental Protection Agency and the Department of Public Health and Social Services attended the hearing, along with

those Yigo residents. GWA issued notifications and "do not drink without treatment" advisories to affected residents in mid-September after the Y-15 water well in Yigo was found to have a dieldrin concentration above the local interim action level, or IAL, for the chemical.

A chief concern among those affected has been the timeliness of communications and actions addressing the contamination. Dieldrin is a pesticide that has been banned for all uses in the US since 1987 and is considered a probable carcinogen. The chemical had been found in dozens of GWA wells dating back to 1996, according to a 2012 inspection and sanitary survey report from the US EPA.

But as officials noted, there wasn't - and still isn't - an enforceable federal maximum contaminant level on dieldrin. The local IAL on the chemical, which requires public notifications when dieldrin exceeds certain thresholds, was adopted by the Guam Environmental Protection Agency just last year and became effective in August this year.

Widespread, low-level

There are 124 different sites on Guam considered entry points for the water distribution system. Out of those sites, 31 or 32 are nondetect for dieldrin, according to Brett Railey, assistant general manager of engineering at GWA.

Another 83 or 84 entry points have had some level of dieldrin detection under half of the IAL, or less than 0.1 micrograms per liter, Railey added. "Islandwide, you could say dieldrin is widespread, but at a low level. There are only nine wells where the detection level of dieldrin is above 50% of the IAL. Of those wells, there are only two wells at present that are over the IAL," Railey said. Read more in the *The Guam Daily Post*.
