PEs Speak Their Minds on the Profession

Engineering Outlook survey, 54% of participants agreed that the job market was good, while 23% strongly agreed. The majority of 2018 survey participants (52% agree and 21% strongly agree) are also satisfied with opportunities for professional advancement in the engineering field.

The Engineering Outlook survey also addresses the public's perception of the engineering

engineering profession to be ethical, with 58% agreeing and 26% strongly agreeing that this

is the case. Yet, when asked about the public's knowledge about the profession, the views

Nearly 54% agree and 28% strongly agree that despite increased attention given to STEM education in government policy, media, and outreach efforts, the public still doesn't know enough about the engineering profession compared to other learned professions (medicine, law, architecture, accounting). 
