We welcome all members of the *Psi Kappa/ Sigma* chapter to present their study/evidence-based project (EBP) in poster format at the Psi Kappa chapter induction ceremony. The Winner of the best poster award will receive *a certificate, plaque and a 150JD cash prize*.

**The Purposes Of The Best Poster Award Are:**

- To create new approaches to promote nursing care.
- To escalate the healthcare professional's competency levels that aims to enhance the quality of patient's care.
- To acknowledge nursing excellence in research and practice.

**Eligibility criteria:**

**Applicants to this award must fulfil the following criteria:**

- Applicant must be an active member of Psi Kappa chapter (2017).
- Applicant is not a current member of the valuation committee of this award.
- Applicant is not a current a Board member of Directors of the Psi Kappa chapter.
- Applicant must be the principle invest of the study/EBP.
- The submitted study/EBP must not be published, accepted for publication, or presented in a professional conference.
- The study/EBP should not be a Thesis/dissertation or a part of it.

**Poster Guidelines**

- The poster should not be larger than 1.2m x 1m.
- Board format: horizontal (landscape)
- Must include a title, the author(s) name(s) in the top right corner.
- Include text, tables and graphs that are relevant, clear, attractive and logically presented.
- The poster contents must be clearly visible from a distance of 30 cm.
- The Font and spacing should be same all over the poster.

## Contents of the Poster

### The Research:

- **Purpose and Background/Significance:** State the purpose of the study and why it is important to nursing science, practice and/or patient care.
- **Theoretical/ conceptual framework:** Include conceptual and operational definitions.
- **Method:** Describe the study design, sample, sampling technique and instrument(s).
- **Results:** Discuss the findings within the context of prior research.
- **Conclusions/clinical implication:** Explain what the findings mean for the science of nursing.

### The Evidence Based Project

- **Nature and scope of the project** (introduction, problem identification, significance, project objectives).
- **Synthesis and analysis of supporting literature.** Describe the evidence-based solution. How was it developed? Include the theoretical framework if applicable.
- **Project implementation:** Describe the implementation process and significant challenges encountered.
- **Outcomes:** What were the outcomes of the project? How were the outcomes measured?
- **Recommendations:** Describe your recommendations for clinical practice and policy based on the outcomes of the evidence-based practice project.

### **Required Documents:**

#### The Research:

- A full text document.
- The applicant' curriculum vita.
- Permission from the co-authors to apply to the award.
- The IRB approval documents.

#### The Evidence Based Project

- A full text document of the project.
- Evidences of at least three outcomes (e.g., results, change in policy, protocol, guidelines, or patients' outcomes).
