- Exhibiting Season Ticket and One Year of Vendor Listing with link and logo paced on the online OCDS CE Homepage is \$2400. One year of Online Sponsorship is normally \$1000. This is a \$500 discount if purchased along with exhibiting season ticket.
- Individual meeting exhibit space may be purchased throughout the year for a fee \$370 per meeting.

All Exhibitor registrations include:

- One 6 ft linen draped table.
- One representative buffet meal.
- Electricity, internet, and exhibitor raffle tickets for raffle participation.
- Insertion of company marketing materials into guest attendee registration packets. Please provide any brochures, flyers and/or business cards *the week prior to the CE event*. We will not be able to include materials received subsequent to this deadline.
- Participating exhibitors will be acknowledged at the meeting.
- A list of all exhibitors will be included in the guest registration packets.
- A list of registered attendees will be provided to each exhibitor the following morning.

Restrictions:

- All payments are due at the time the reservation is made.
- Space is limited and will be confirmed on a first-come, first-paid basis.
- Only one vendor per table – no sharing of space is permitted.
- A registration fee of **\$60 for each additional representative per meeting**. This fee includes one buffet meal.
- Electricity and internet access are available. Resources require advance notification.
- Exhibitors may set up their displays at 4:00 pm. Exhibit Salon doors remain locked until then.
- **Vendor table locations are pre-assigned** at the discretion of OCDS. Your table assignment will be indicated by company signage on each table. You will be required to relocate if table has been designated to another vendor.
- There are no refunds available for unattended meetings.

- Guest registration begins at 5:00p.m.
- Buffet dinner begins at 5:30p.m. Buffet, dining tables and exhibitor tables will be in the same location.
