Our Union Working Hard for you:

- L&D SBIP Grievance – We fought to make sure that L&D was eligible for SBIP when management was not including open positions in the functional vacancy rate.
- Holiday SBIP Grievance – We fought for and won backpay for nurses who signed up for SBIP during a holiday week. To qualify for this remedy, the nurse had to have **not** worked the holiday, worked their full FTE, and scheduled their extra day on the observed holiday benefit day.
- Workplace Violence Grievance – After a meeting with executive leadership to discuss the conditions on the floor, the Hospital is committed to continuing work to improve safety and will collaborate on workplace violence with OSUNO during Professional Nursing Practice Committee.
- Sharps Grievance – OSU has invested in new sharps containers and more will be placed around the hospitals to prevent overly full containers.
