I spoke with the Franklin County Public Health Department about the availability of the Covid-19 vaccines. I was informed that at this time they are not scheduling people for the vaccination.

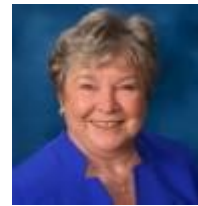
