# Colonel George D. Scott Award

The Colonel George D. Scott award policy paper and nominating form shall be sent to those individual state associations considering the submittal of a nominee.

The Colonel George D. Scott Award was initiated in 1968 to provide a perpetual memorial for our first president and at the same time recognize a member for meritorious service.

In establishing this award, the Board of Directors designated the responsibility of selecting the recipient to the PHCC Policy Committee. The 1968 Policy Committee provided the following guidelines:

- This meritorious award is created for giving formal recognition to members who have shown outstanding dedication of service to the National association, affiliated associations and to the plumbing-heating-cooling industry.
- Emphasis in selecting nominees should be given to sustained service for any given complete ten-year period with a multiplicity of specific deeds rather than a single outstanding deed. Evaluation should be made of effects and results of a single person's influence.
- An average minimum score of 70 points must be achieved on the combined judged evaluation forms for a candidate to receive the award. (rev. 10/24/07)

The background information on this award shows the following eligibility requirements:

- A. Nominees shall be endorsed, and forms submitted by the candidate's local and state association.
- B. Candidates shall be current members of any class of PHCC who shall have been active members continuously for any ten-year period completed in total prior to nomination of the award.
- C. The nominee need not have held any national office or position.
- D. No member may receive this award more than once.
- E. The list of those ineligible (see Policy 1.4.1) shall be noted on the form.

In selecting a nominee, special consideration should be given to the extent of his or her influence and diversity and duration of his or her service. Candidates for this coveted award should be submitted by the local and state association with background information justifying the candidate's qualifications to be a recipient of the award to the PHCC Policy Committee, 180 S. Washington St., Suite 100, Falls Church, VA 22046, no later than 60 days prior to the PHCC Annual Business Meeting.

It was further stipulated by the Executive Committee in June 1977 that this award need not necessarily be an annual award nor presented at each Annual Business Meeting but would be presented only when a candidate met the outstanding service requirements as set forth in the guidelines. If a candidate is selected, presentation will be made at the Annual Business Meeting.

No PHCC sitting officer shall provide a written recommendation for a 282 candidate being considered for the Col. Scott Award. (May, 2019)

### **Nomination Guidelines**

# Colonel George D. Scott Award

The Colonel George D. Scott Award was initiated in 1968 to provide a perpetual memorial for our first president and at the same time recognize a member for meritorious service. This award formally honors members who have shown outstanding dedication and service to the National Association, affiliated associations, and to the plumbing-heating-cooling industry.

The PHCC Policy Committee will review all forms and select a recipient. This award will not necessarily be awarded every year but will be presented only when a candidate meets the outstanding service requirements as set forth in the guidelines. If a candidate is selected, presentation will be made at the Annual Business Meeting.

Candidates for this coveted award should be submitted by their state or local associations. Only one nomination from a state/local association will be considered annually.

### Eligibility

- 1. Candidate shall be a current member of any class of PHCC who has been continuously active for any ten-year period completed in total prior to nomination of the award.
- 2. Candidate need not have held any national office or position.
- 3. No member may receive this award more than once.
- 4. Active members of the Nominating Committee, Policy Committee, Board of Directors, or staff are not eligible.

### Guidelines

- 1. Form must include formal letter of submission from affiliated state or local association, signed by the President and one other officer of that association.
- 2. Nomination Form must be filled out completely.
- 3. Special consideration should be given to the extent of the candidate's influence, diversity, and duration of service.
- 4. Sustained service over the entire ten-year period is also very important.
- 5. An ideal candidate will have numerous specific deeds rather than a single outstanding deed.
- 6. Attention should also be given to the effectiveness and results of the person's influence.
- 7. No PHCC National sitting officer shall provide a written recommendation for a candidate being considered for the Col. Scott Award. (see Policy 1.4.1)
