

Message from PHCC National Association EVP

Dear Auxiliary Family,

I hope this finds you all safe and well. As of this writing, most of the country has been closed for many weeks with essential workers on the front lines keeping us all safe. As PHCC National President-Elect Hunter Botto observed recently, "Every aspect of everyone's life and professional career is being redefined." PHCC contractors are reimagining their businesses and implementing new ways of conducting business while protecting their employees and clients under the 'new normal'. This means that the value we provide as an association has had to pivot in order to meet members' changing needs. Staff and members alike have compiled best practices and guidance in the new online COVID-19 Resource Center to include updated customized resources, short instructional videos, advice from experts, and tips developed specifically for and by p-h-c contractors. In addition there is an Online Discussion Forum for members to discuss COVID-19 concerns. I look forward to when we can shift our efforts to a "COVID-19 Recovery Center."

Even during a pandemic, our work never stops. The PHCC Educational Foundation signed the White House Pledge to America's Workers to train 75,000 students over the next five years. This also entails attracting more minorities and women into the industry as illustrated by the exceptional Auxiliary <u>videos</u> showcased last fall at PHCCCONNECT2019. I have to admit that I got a bit weepy when watching them. The PHCC National Association continues to attract Corporate Partners and sponsors who want to invest in workforce development including the great efforts of the PHCC National Auxiliary.

The Association has actively advocated for several emergency spending bills to deal directly with the Coronavirus outbreak. Congress is currently considering more legislation to provide relief from the economic impact for small businesses—and PHCC National continues to lobby for its passage. As part of a broader strategy to look out for the interests of our federation, we have also reached out to the administration and Congress urging them to ensure that non-profit associations are not excluded from any eligibility for aid being proposed.

I wrote back in 2016 that "having managed my own small business after my military service, I believe that sustainable team success is achieved through constructive collaboration... and that ultimately the PHCC Federation success is mutually dependent upon the success achieved by each stakeholder within it." Beginning in July of this year, the PHCC—National Auxiliary will become integrated as a vital part of the PHCC National Association while maintaining its passion to promote "public awareness of the industry through education and communication." We are very excited as we work through this transition and collaborate to meet the needs of all of our members.

So for now, as Past National President Patrick Wallner likes to say, "Take Care and Be Aware."
