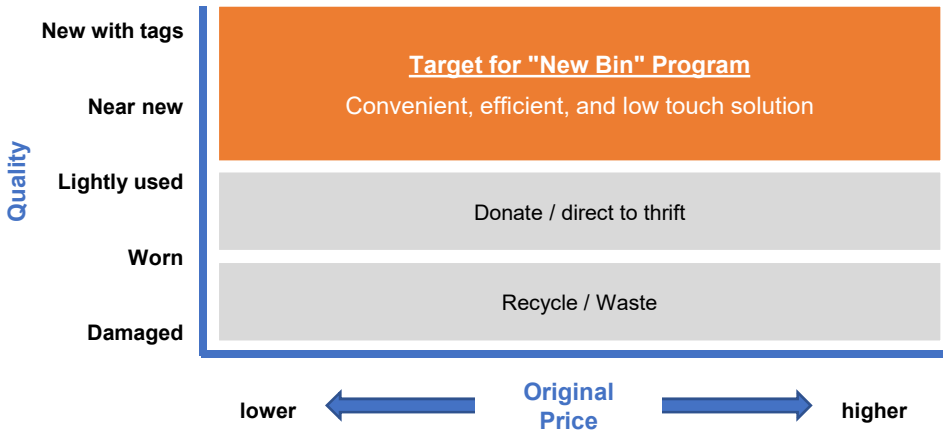

Terms & Conditions:

PLEASE READ THESE TERMS & CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THE PROGRAM

TOGI is offering the Program as a convenient option for organizers to remove large quantities of quality product, across multiple categories, for sale. The Program is being offered as a pilot program. The following Terms & Conditions (the "Terms") apply to each organizer participating in the Program ("you") and to TOGI ("we", "us", or "our"), govern the Program, and are part of the legally binding agreement between you and us.

Please read these Terms carefully. By signing up for the Program, you agree to be bound by these Terms and you represent and warrant that (1) you have read, understand and agree, to be bound by these Terms, (2) you are of legal age under applicable law to form a binding contract with us, and (3) you have the authority to enter into the Terms on behalf of yourself, the company that you represent, or your clients.

If you do not wish to be bound by these Terms, you may not participate in the Program or use or access the services offered within the Program.

You agree to submit any disputes, claims or causes of action against TOGI ("Claims") exclusively to binding and final arbitration on an individual basis, not as a plaintiff or class member in any class, group or representative action or proceeding and you hereby irrevocably waive your rights to have such Claims heard in a court of law. Such arbitration shall be conducted by and in accordance with the rules of the American Arbitration Association in Atlanta, Georgia

Payment:

Once items have been processed, items accepted for purchase will be priced by our pricing specialists. Pricing may be impacted by item brand, quality, age/relevance as well as our inventory needs. You will receive a list of the accepted items and the estimated prices with a check of 30% of the total value. Items may take up to 30 days to process from date of TOGI's receipt. You agree that no items will be returned for any reason including (1) item pricing, or (2) rejection for purchase. Final sales price may vary slightly from initial estimate. No monies will be exchanged between you and TOGI for any such variances.

Product acceptance and payment :

You agree that all items submitted to TOGI shall immediately and irrevocably become the property of TOGI and will not be returned, whether or not such items are accepted for purchase. Payment will be made only for items that meet all acceptance criteria. Acceptance criteria include category and quality standards. Across all categories and qualities, product will be rejected if dirty, stained, odorous, damaged, counterfeit, monogrammed, vulgar or profane.

Any items that do not meet our category and quality standards will not be accepted for purchase. TOGI reserves the right to sell or donate rejected items to third-party recyclers without any obligation to compensate you for such unaccepted items.

Product acceptance will be based on quality and condition at the time shipments are received. TOGI is not liable for any damage sustained during shipment.

TOGI will accept items in the following categories:

- Women's clothing
- Men's clothing
- Children's clothing
- Accessories (e.g., handbags, wallets, scarfs, ties, belts)
- Shoes
- Formal wear
- Jewelry
- Sunglasses / eyewear
- Hand tools
