On behalf of the organizations we lead, the [Population Association of America \(PAA\)](#) and [Association of Population Centers \(APC\)](#), we congratulate you on your recent appointment as the Director of the Office of Behavioral and Social Science Research (OBSSR) at the National Institutes of Health (NIH).

PAA and APC are two affiliated organizations representing over 3,000 behavioral and social scientists, including demographers, sociologists, economists, and epidemiologists, and over 40 federally funded U.S. based population research centers. Population scientists study the individual, societal, and environmental consequences of population change. Their expertise covers a wide range of topics including mortality, morbidity, fertility, adolescent health, aging, population forecasting, immigration, and human-environmental interactions.
