### **SPEAKERS**

**Tim Field, PhD** taught for several years at the University of Georgia in the area of rehabilitation counseling. Since 1979, he has been the President of Elliott and Fitzpatrick, a publishing company specializing in professional rehabilitation literature. Among publications too numerous to list here, Dr. Field founded the Journal of Life Care Planning and continues writing and publishing in the field today.

Dr. Field is our keynote speaker and has provided this information about his presentation: As the profession of private sector rehabilitation continues to evolve and mature, professionals can rely upon 50 years of experience and a literature base from which to practice. However, several critical issues need to be re-visited on occasion as case law continues to define and shape the practice of private rehabilitation. Dr. Field will address several of these concerns including such topics as admissible testimony in federal courts, challenges to expert testimony, developing a defensible opinion, life care planning, and the Affordable Care Act. Each of these topics will be discussed in the context of federal court cases and the federal rules relative to vocational and life care planning expert testimony. Selected cases will be used to illustrate how the expert performed within the context of the law, regulations, and relevant rules.



**Kellie Camelford, PhD, LPC-S, NCC** is an LPC-Supervisor and National Certified Counselor who specializes in adolescent and women's issues. Dr. Camelford works with individuals, families, and groups; and has experience with issues such as anxiety, cyberbullying, depression, divorce, gender / identity exploration, grief, infertility, life transitions, mindfulness, postpartum depression, self-esteem, self-harming, stress management, and social skills development.

**Todd A. Delcambre, JD** is a 1995 graduate of LSU Law School. His areas of practice include Maritime/Jones Act, Longshore Claims, Louisiana State Worker's Compensation, mediation services, insurance and reinsurance law as well as subrugation. He is a former mediator of the Louisiana Office of Worker's Compensation. Mr. Delcambre has been a integral member of the LeBas Law Offices of Lafayette for several years.

**Erin Dugan, PhD, NCC, CRC, LPC-S, RPT-S** is an LPC-Supervisor and a Registered Play Therapist-Supervisor specializing in children (ages 2-12), attachment disorders, and child-parent relationship therapy including filial therapy and family play therapy. In addition to her clinical work, Dr. Dugan is an Associate Professor in the Department of Clinical Rehabilitation and Counseling at the Louisiana State University Health Sciences Center- New Orleans and serves as the Associate Dean of Academic Affairs in the School of Allied Health Professions at LSUHSC as well as the Interim Department Head of the Department of Clinical Rehabilitation and Counseling. She is recognized as a leader in the field of play therapy, presenting both nationally and internationally at professional conferences and publishing scholarly works on the subject.

**Jill Hayes, PhD** is a Clinical and Forensic Neuropsychologist who examines the psychological and neuropsychological functioning of individuals. She provides opinions regarding her findings in both civil and criminal proceedings. She offers therapeutic services tailored to the issues and context of individuals experiencing psychological difficulty. Dr. Hayes will speak to IARP – Louisiana regarding the Neurophysiology of Traumatic Brain Injury. She will discuss the information and process she utilizes to develop her diagnosis and opinions.



Scott E. Landry, MS, CRC is a Major in the Louisiana Army National Guard, (P), 225th Engineer Brigade S-6. He currently serves as a Telecommunications Manager and manages a staff of 490 personnel. He is a Combat Veteran of Operation Iraqi Freedom III, Operation Iraqi Freedom X and Operation New Dawn. Major Landry has a Master of Science in Rehabilitation Counseling from the University of Southwestern Louisiana in 1996. He has worked in private sector rehabilitation since 1996 and has had his own practice, VocStat Rehabilitation LLC since 2006.

William R. "Randy" Long was admitted to the Louisiana Bar in 1987 after completing his Juris Doctor at LSU in 1987. He has practiced law in the the Shreveport-Bossier City area specializing in Plaintiff Personal Injury, Worker's Compensation Law and Social Security Disability.
