



NETWORKING RAFFLE AND RECEPTION

The Annual Florida RIMS Networking Raffle and Reception is scheduled for Wednesday, July 31, 2019 from 3:00pm to 5:30pm in the Vanderbilt Ballroom at the Ritz-Carlton, Naples.

Participation as vendor in the Networking Raffle requires that at least one representative from the company be registered for the Florida RIMS Conference for the entire week. Note: only conference registrants will have access to all of the conference educational events, including the sponsored breakfasts, lunches, and evening receptions.

The Network Raffle provides an opportunity for conference attendees to interact informally with conference sponsors and vendors in a casual, fun filled environment. Attendees purchase raffle tickets, examine the displayed gifts and place raffle tickets in the basket with the vendor of their choice. The name of the vendor providing the gift is announced as the winning ticket number is being drawn.

- 1) Register for the Florida RIMS Conference at: <http://florida.rims.org>, using the eventbrite link.
- 2) Complete the Networking Raffle Participation Form and send it to the individual listed on the form. Donated raffle gifts must be delivered to the Ritz-Carlton Vanderbilt Ballroom by 12:00 Noon on Wednesday, July 31, 2019 in order to provide time to set up the room for the Raffle and Reception.
- 3) Provide a gift with a minimum value of \$200.00.
- 4) All Networking Raffle participants may send their raffle item directly to the hotel (**no earlier than July 22 – Monday before the conference**) addressed to: The Ritz-Carlton Naples, 280 Vanderbilt Beach Rd, Naples, FL 34108-2300, Attn: Natalia Niederwieser, FL RIMS Conference Networking Raffle. **Shipping label MUST indicate “Networking Raffle” for proper delivery.**

Please remember you may have to share a table, so your signage for the table must not exceed 2 feet x 2 feet, any draping would be limited to half of a table and the area immediately behind your table can contain additional company displays if it is free standing and does not require attachment to the wall (i.e., a retractable banner display). Be considerate of the space - it is inappropriate to bring oversized booths, towering displays or banners to the Vanderbilt Ballroom outlining the company’s products and services.

Proceeds from the raffle will be used to support the Florida RIMS Conference.
