PROGRAM: Regulatory Risk – how it impacts an organization

SPEAKER: Greg Barnlund - Manitoba Hydro Rates & Regulatory Affairs Manager

Greg Barnlund is the division manager of Rates and Regulatory Affairs at Manitoba Hydro. Greg graduated from Red River Community College in 1988 with a diploma in mechanical engineering technology and started his career in the utility industry in 1989. He has been employed with Manitoba Hydro and Centra Gas Manitoba for twenty-seven years.

Prior to his appointment as division manager of Rates and Regulatory Affairs in 2013, Greg gained a wide range of experience in the utility with responsibilities for regulatory affairs, gas supply, utility rates, customer policy and industrial & commercial marketing.

His responsibilities include overseeing the preparation of regulatory filings and applications before the Public Utilities Board of Manitoba and the National Energy Board and directing the regulatory activities between Manitoba Hydro and those regulatory bodies. In addition, Greg has testified as a witness at regulatory proceedings before the Public Utilities Board, the National Energy Board and the Federal Competition Tribunal.


