Texas Supreme Court Holds that "Like Kind and Quality" Can Include A More-Expensive-Than-Identical Replacement: *Republic Underwriters Ins. Co. v. Mex-Tex, Inc.,* Texas Supreme Court, Cause No. 03-0662 (Nov. 19, 2004)

This case deals with the issue of what the terms "like kind and quality" of "comparable material and quality" mean in a property policy. Property policies typically allow the carrier an option to replace with "like kind and quality" and of "comparable material".

In this case, Mex-Tex's roof was damaged by hail. Mex-Tex replaced the roof with a more expensive roof which was different from the original because it was mechanically Continued on page 3...

SENATE BILL 127 (sb 127) ADJUSTER LICENSING

After several years of lobbying efforts and in the wake of the recent mold crisis, the Texas Legislature has passed a law requiring licensure for public insurance adjusters. These adjusters, also known as loss consultants, assist insured clients with the measurement, documentation and negotiation of first party property claims, contents inventory and business interruption accounting. Public insurance adjusters are hired to outsource the claims management for the insured client and do not represent insurance companies.

Jansen International, LLC and other members of The Texas Association of Public Insurance adjusters (TAPIA) were instrumental in working with the Governor's office and legislature to pass this bill. "We applaud this effort and are pleased with the outcome" stated Art Jansen, Jr., President of TAPIA. "This bill will bring a needed improvement in the professionalism and credibility of our industry". Concurrently, The National Association of Public Insurance adjusters (NAPIA) is working with the National Association of Insurance Commissioners (NAIC) to establish a national license bill that will apply to all states. A vote on this issue in mid December by the Commissioners is expected to pass.

The license requirements are similar to those of other adjusters and include criminal background checks, a state administered examination, fiduciary bonds and continuing education. The bill also generated a pre-approved retainer agreement that allows a 72-hour cancellation option for the client and a fee capped at 10 percent of the amount adjusted in the claim. Solicitors and adjusters must be licensed to practice in Texas.

If a RIMS member should suffer a property loss and seek to outsource this function, they should always ask for proof of licensure, a formal proposal for services and check the company's references. attached to the structure (not by ballast - or rocks-as was the original roof).

The carrier, Republic, offered to pay for the cost of replacing the roof with an identical roof. It argued that by definition, an identical roof was of "like kind and quality". Mex-Tex sued to make Republic pay for the more expensive roof. The Supreme Court upheld the trial court's finding that This course is part of a three-semester specialty program Republic breached its policy. The Texas Supreme Court stated that the "plain language of the policy neither restricted nor required Republic to pay for the cost to replace the roof with an identical one". The more expensive roof was also of "like kind and quality" and Republic breached its contract by failing to pay for the more expensive roof.

> The Texas Supreme Court also held that the 18 % penalty under the Prompt Payment of Claims Act, Article 21.55, should be based on the difference between the amount that Republic offered to pay, and the amount of the claim ultimately found by the trial court, not on the full amount claimed by Mex-Tex.

> Finally, although the Texas Supreme Court stated that a conditional offer to pay would not stop the assessment of penalties under Article 21.55, in this case, the Texas Supreme Court found that the offer made by Republic was not conditional. The Texas Supreme Court reviewed the factual evidence relied on by the trial and appellate courts, and found that the evidence did not support a finding that the offer was conditional.
