Terry McSween, Ph.D.
President of Quality Safety Edge

Behavioral safety is a proven approach to reducing injuries. This presentation will discuss why companies are interested in behavior-based safety, define the key elements of a behavioral approach, and provide an overview of typical results. Dr. McZee will also present data showing the impact of the behavioral approach on the costs associated with injuries, and discuss common concerns, such as the involvement of leadership and blaming the employee. Dr. McSween will also talk about the importance of designing a behavior-based process in a way that builds employee ownership and stronger values supporting safety.

Dr. McSween is a nationally recognized expert in the field of behavioral safety. He is CEO and cofounder of Quality Safety Edge, a company that helps organizations improve safety and leadership through behavioral psychology. During the last twenty years, he has worked with a large number of risk management size accounts. Dr. McSween is the author of the book, *The Values-Based Safety Process* (John Wiley & Sons, 1995) and has won numerous awards for his work in behavioral safety, including the 2001 Outstanding Contribution award from the International Association of Behavior Analysis. His is also founder of the Behavioral Safety NOW, an annual professional conference for behavioral safety users and practitioners.
