## **Property Recovery Process Planning**

In June we took a look back at Tropical Storm Allison and the lessons we have learned. Many of us took valuable information back to our offices to help us to improve and clarify our current flood policies. We were urged to be prepared through disaster planning. This month, we are taking disaster recovery planning one step further. Michael D. Stall, MSCE, PE of Managed Response, Inc. will discuss how business continuity planning can incorporate the property recovery puzzle for rapid and cost effective recovery.

Michael's presentation will highlight how businesses of every size can prepare for the actual response, restoration and reconstruction part of the disaster recovery process. The presentation will emphasize how to minimize unrecoverable costs and how to maximize any possible benefits of such a disaster. Actual photos, specific recovery examples and case studies will be presented that will illustrate lessons learned from varying types of losses.

Mr. Stall has a Masters of Science in Civil/Construction Engineering from Stanford University, a Bachelors of Science in Architectural/Structural Engineering from the University of Texas at Austin, TX, and is a Registered Professional Engineer in Texas. He is a licensed contractor in several states including California and Florida. He is President of Managed Response, Inc., a firm that specializes in disaster preparedness planning, loss recovery management, and reconstruc
