RISK MANAGER IN RESIDENCE – ROGER L. ANDREWS, J.D.

Please join us for the February monthly meeting of the RIMS Houston Chapter. We are honored to feature UHD and Spencer Foundation's Risk Manager in Residence, Roger L. Andrews, J.D., Director of Risk Management for E.D. Bullard Company located in Cynthiana, Kentucky. Mr. Andrews has served in various risk management positions during his career including drafting the legislation that created the Risk Management Division and was the first Director of Risk Management for the State of Maine in the early 1980s; served as property and casualty manager for Hannaford Bros. Co., and Director of Risk Management for Bath Iron Works. Prior to law school, Mr. Andrews worked as a commercial underwriter for Travelers Insurance Company in Hartford, Connecticut.

Mr. Andrews has been active in RIMS for the past 33 years in various capacities. He is currently a member of the Board of Directors and former Chairman of the Spencer Educational Foundation. Mr. Andrews was the 1997 recipient of the Richard W. Bland Memorial Award for outstanding contributions in the area of legislation. In 2003, Roger was recognized by *Business Insurance* and RIMS as a member of the Risk Management Honor Roll. In 2006, Roger was awarded RIMS' highest award, the Harry and Dorothy Goodell Award for outstanding contributions to risk management and to RIMS.

Roger received a BA degree from Brigham Young University, a JD from Thomas Jefferson School of Law (then Western State University College of Law) in San Diego and is an inactive member of the State Bar of California. He and his wife Joelyn, have seven children and sixteen grandchildren.

Mr. Andrews will be presenting the topic, "**Litigation Management: The New Risk Model**". More than 70 major US companies have declared bankruptcy while fighting the tide of asbestos litigation. Some believe that had they managed the litigation differently, most might still be in business today. This discussion will focus attention on the risk management model as an effective template for managing litigation and will examine this topic from the perspective of a risk manager with more than thirty years of experience managing thousands of lawsuits.
