Scott D. Schoonover was appointed to Deputy Chief of Support Service for the Spring Fire Department on January 1, 2011, having been selected by former Fire Chief Eric Anderson.

Chief Schoonover began his firefighting career in 1996 with the Spring Fire Department. He worked in various capacities within the organization including Lieutenant, Captain, Senior Captain, and Fire Marshal.

Chief Schoonover also serves as a Lieutenant Investigator with the Harris County Fire Marshal's Office and holds an Advanced Peace Officer's License. He supervises Law Enforcement personnel conducting arson investigations for the unincorporated areas of Harris County.

Chief Schoonover has previously worked at Cypress Creek EMS and Montgomery County Hospital District as a Senior Dispatcher. In 2005, during Hurricane Rita, Schoonover was involved in the coordination of evacuating hospitals and nursing homes in the East Texas and Louisiana regions.

Chief Schoonover also worked at Eastex, Champions ESD 29 Fire Department, and as a patrol deputy with the Harris County Precinct 4 Constable's Office under now Sheriff Ron Hickman. He is also a member of the International Association of Fire Chiefs, International Association of Arson Investigators, and Association of Certified Fraud Examiners.

Chief Schoonover holds multiple Advanced and Master certifications in the Fire and Law Enforcement disciplines.
