Tips to prevent employees exposure to the West Nile Virus

July 26, 2004 AUSTIN, TX - During the summer, when mosquitoes are the most active, the Texas Workers' Compensation Commission reminds employers and workers to take precautions when working outside. Workers at highest risk of exposure to the West Nile Virus are those working outdoors during times when mosquitoes are actively biting. Occupations at risk include farmers, foresters, landscapers, groundskeepers, painters, roofers, road pavers, construction workers, and other outdoor workers. Preventing mosquito bites reduces the risk of contracting the West Nile Virus, along with other diseases that mosquitoes can carry.

Employers can protect their employees by establishing safe practices while working outdoors.

- · When possible, do not schedule work at dawn and dusk to avoid having workers outdoors when mosquitoes are most active and biting.
- · Eliminate as many sources of standing water as possible to eliminate mosquito-breeding areas. Change the water regularly in animal drinking troughs, ponds and other standing bodies of
- Turn over, cover, or remove equipment such as tarps, buckets, barrels, and wheel barrows that accumulate water.
- · Discard tires, buckets, cans, and containers in the area.
- Place drain holes in containers that cannot be discarded.
- Clean out rain gutters and ditches to get rid of standing water.
- · Fill in ruts and other areas that accumulate water.

Recommendations for workers

Outdoors workers can decrease their risk of West Nile Virus infection by reducing their contact with mosquitoes through the use of the personal protective measures.

- · Wear long-sleeved shirts, long pants, and socks when possible.
- Spray exposed skin with insect repellents.
 - Read and follow label directions for repellent use.
 - Use repellents at the lowest effective concentration.
 - Use repellents containing DEET (N-N-diethyl-3methylbenzamide or N,N-diethylmetatoluamide) at concentrations of 35 percent or less.

IN RE DANA CORPORATION: THE PRODUCTION OF INSURANCE POLICIES IN LITIGATION BY: JAMES L. CORNELL*

If you are ever unfortunate enough to be involved in litigation, you are familiar with the process known as "discovery". This is the pre-trial phase of the suit in which each party is permitted to ask written and oral questions, and ask for documents. Discovery can often be quite contentious, requiring the intervention of the Court.

In almost all cases, the Plaintiff will request the production of any insurance policies that might be applicable to cover a claim. This request sounds simple enough, but in toxic tort or environmental cases in which potential exposures span several decades, producing insurance policies over a 20 to 30 year period can be quite challenging.

That was the situation in the Dana case. There, Dana had been sued by 1260 Plaintiffs who sought production of insurance policies from the 1930's. The trial court ordered the production, but the Texas Supreme Court limited the production to only those policies shown to be applicable to the underlying litigation. In other words, since the Plaintiffs could only produce affidavits showing exposure dating back to 1945, Dana did not have to produce policies which pre-dated 1945.

That's still a very difficult task for most companies, but is far better than producing policies back to the 1930's.

Practice Pointer: Never assume that you do not need copies of your policies after the policy term expires. Be sure to keep copies in a safe place. If your company is acquiring another company, an inventory of the new company's policies should be a priority task.

- Do not apply repellents to cuts, wounds, or irritated skin.
- When needed, reapply repellents according to label directions.
- Spray clothing with products containing DEET or permethrin, as mosquitoes may bite through thin clothing.
 - Wash treated clothing before wearing it again.
 - Do not apply repellents under clothing.

The Texas Workers' Compensation Commission offers resources to help employers teach their workers how to avoid contact with mosquitoes that may transmit the West Nile Virus.
