Spotlight on
ROBERT C. CARD,
CPCU, ARM, Are

In the RIMS Houston Chapter, we have many members with various titles, designations, etc. There are members who have been promoted because of outstanding accomplishments, received professional designations, and published articles just to name a few. Often times, these outstanding achievements are not public knowledge. Therefore, we have decided to Spotlight our members for their accomplishments. This months *Spotlight* is on **Robert Card, CPCU, ARM, ARe, of Philip Services Corporation** for his article that was published in the February 2002 Risk & Insurance Magazine (*A New Paradigm for a Competitive Market*).

Robert is the Assistant Treasurer and Director, Risk Management at Philip Services Corporation since 2001. Robert was recruited to assist in the turnaround of this \$1.6 billion, 11,000-employee industrial service firm as it emerged from bankruptcy, and moved its corporate offices from Canada to the U.S. He manages a department of eight (8) with costs of risk in excess of \$30 million per year. Together with his department, they restructured PSC's insurance program to comply with multiple conflicting corporate objectives, reorganized the claims department to more aggressively manage large losses and redesigned their management information system to provide greater financial analysis and speed of reporting. Robert and his group also provided millions of dollars in additional liquidity to the company through reduction of outstanding financial assurance mechanisms and restructuring of capital within the company captive. Some of his major continuing challenges include management of an offshore captive with significant liabilities and rebuilding surety capacity through conventional and non-conventional alternatives, including development of an onshore captive insurance company.

Robert will be the moderator at one of this year's RIMS sessions in New Orleans. The session is titled "Understanding C-FAR (Cash Flow at Risk), Session FN401 on April 16, 2002 from 3:00 p.m. to 5:00 p.m.

Let us congratulate Robert for his outstanding achievements.
