Speaker Bio
Doug Ommen
Deputy Commissioner
Iowa Insurance Division

Doug Ommen was named Deputy Commissioner in the Iowa Insurance Division in August 2013. He has responsibility over the Division's Market Regulation Bureau, the Fraud Bureau and the Enforcement Bureau.

A native of Missouri, Doug served in the Missouri Department of Insurance during 2005 – 2008, and as Insurance Director was instrumental in working with industry for several key regulatory reforms, including the adoption of annuity suitability standards and market conduct regulations. Much of his law enforcement career was in the Missouri Office of



Attorney General, where he led the fight to protect consumers over the course of three decades. Doug prosecuted securities frauds, real estate and mortgage frauds, and most recently auto warranty frauds obtaining substantial sentences, putting numerous white collar criminals behind prison bars. During his term as Missouri Securities Commissioner, Doug was the first securities commissioner in Missouri history to be cross-designated as a prosecutor to bring criminal indictments for securities fraud.

Doug obtained his law degree in 1985 from the Saint Louis University School of Law, and is licensed to practice law in both Iowa and Missouri. He has received his MCM designation from the Insurance Regulatory Examiners Society.

Doug is an avid basketball fan and has coached numerous middle school basketball teams. His reputation as a player on the court involves arms, elbows and any other legal maneuver to gain advantage over his opponents.
