Our Saskatchewan RIMS Chapter Scholarship is awarded in the amount of \$1,000. This will be split in two payments, delivered at the beginning of the Fall '25 and Winter '26 semesters, to a student who meets the following criteria:

- (1) Must be interested in seeking a career in Risk Management, Insurance, Cybersecurity, and/or Actuarial Science.
- (2) Must be enrolled full-time at an accredited college, university or institute in Canada.
- (3) Must be a Saskatchewan resident.
- (4) Preferred (but not required): Majoring/minoring in Risk Management/Insurance or a related field of study (e.g., actuarial science, business, finance, information technology).
- (5) Preferred (but not required): Relevant work/internship experience and leadership skills.
