TOPIC: **Rise of the Drones- Unmanned Aircraft Systems** 

> Unmanned Aircraft Systems are already affecting Canada's insurance industry with dramatic implications. The use of drones is becoming increasingly commonplace as companies across a variety of industries take advantage of the many opportunities for cost saving and risk mitigation. Meanwhile, the insurance industry is also getting ready to utilize drones, both to test the risks involved with their customers from an underwriting point of view, and also for their own claims evaluation - particularly after catastrophic events.

> This session will explain drone terminology and discuss its biggest impacts - both now and for the future. You'll find out all about the security and privacy concerns associated with drones, and how Canada fits into the drone race as compared to the US. You'll also learn about Transport Canada's rules for drone use and its impact in the mining and energy industry.

SPEAKERS: **Kate Browne** is an attorney with more than twenty five years'

experience. She spent her entire career in the insurance industry first as an attorney at Mendes & Mount where she represented the London Market Insurers in complex coverage actions including asbestos, pollution, and mass torts. In this capacity, he has been involved in the definition and delivery of airborne surveillance systems and services to military, government, and commercial organizations in Canada and abroad.
