Financial Statements and Auditors Report

- Dan provided the following update:
 - Currently sitting around 104k however have another 17k waiting to come in which would put us at 120k
 - This is prior to the coming sponsorship cycle estimating 67,500 this coming term
 - We have asked each sponsor for an additional 500 this year due to inflation/addition of several events



- This year such included the U30 Event and the SARIMS Engagement Challenge
- o In short, we are healthy even though costs have increased overall for our event
- Dan explained some of the issues we had with Eventbrite this year, however we have now resolved the issue and Eventbrite has released the holiday gala funds (therefore these funds are included in the numbers above)
- March 2025 financials are sitting with the auditor now
 - We had also changed accountants last year due to the passing of the previous auditor
 - They are currently going back a number of years to review previous financials as there were some misclassifications in previous years, however we believe these are now resolved
- Once the financials are done, we will post to the website which will likely be July or August

Portfolio Summary

Sponsorship

- 4 levels still offered for the coming terms
- Nick has kicked off the sponsorship request for '25 to '26
- We tend not to see sponsors dropping off instead we have new ones coming in
 - One from Axis capital
 - Elliot from Trisura
- This year we have not actively tried to pursue additional sponsors but have relied on incumbents and those that approached us

Charitable contributions

- SARIMS supports a number of local charities

- Will be reducing one (the police road safety donation) for the coming year
- Total last year was 13k but will drop to 11k this year
