SARIMS has completed the process of selecting a new accounting firm to succeed Sylvia F. DeLauretis Professional Corporation. Following a competitive RFP process, which involved a thorough assessment of both cost and expertise, SARIMS is pleased to announce the appointment of Dart Bryant LLP as its new accounting firm.

Dart Bryant LLP will be conducting a review engagement for the fiscal year ending March 31, 2025. Once completed, the reviewed financial statements will be made publicly available on our website. We appreciate your continued support and look forward to sharing further updates at the upcoming Annual General Meeting.

- October: This month's session focused on Counter Terrorism touching on Extremism and its rise in society.
- **November**: Grant Smith of NFP shared insights from his extensive experience in marine and energy markets. A key highlight was an overview of the Baltimore Bridge Collapse.
- January: A "State of the Market" session explored trends and rate movements in the Property, Casualty and D&O segments.
- **February**: Jeannine Adams and Sat Parhar led a compelling discussion on Al's dual role in cybersecurity—both as a threat vector and a defense tool.
- March: Gerald Kim and Scott Schellenberg walked us through the "Forensic Accounting Royal Rumble," offering perspectives from both insurer and insured on business interruption claims.
- **April**: Amberly Dooley of Pathways Alliance and Brad Vescarelli from Marsh presented an informative session on carbon capture, storage and related technologies and innovation.

Networking was also a significant part of the breakfast sessions. It was a fantastic opportunity to connect with fellow professionals, exchange ideas, and build relationships that can help us grow both personally and professionally. The collaborative atmosphere fostered a sense of community and shared purpose.
