## IT'S WHAT I DO



I hate standardized tests. I never did well on them in school. So when my boss offered a bonus if we passed the CRC exam, I wanted no part. Most of my career at that point had been in credit and lending - I began my banking career in what was then NCB's "MBA Training Program", and worked mostly on larger middle-market leveraged loans in the years after my rotations were done. I handled diverse credits nationwide - everything from metal-benders to diet powder manufacturers—and gained specializations in utilities, energy and insurance along the way. I structured complex credits, and could quickly dissect financial statements. Returned to Cleveland and NCB in a loan review spot after a stint

with another bank and in financial services consulting, and saw absolutely no need to prove my credit skills by passing any exam. But I was gently informed that since Loan Review was part of the Audit Group, where certifications are de rigueur (CPAs, CIAs etc.) and rightly so, I had better start studying.

When I passed the exam December 2007 on the first attempt, I was very surprised to find it meant so much to me. While the study guide is helpful and I spent significant time reviewing basic concepts, the exam truly tests accomplishments - not memorization skills. There is little "standardized" about it. I attended Northwestern for my BS and Stern (NYU) for an MBA-back when shaky SAT and GMAT scores did not immediately disqualify J—and the CRC probably means more on my resume than both of those degrees, particularly after years out of school. The CRC designation cannot be fudged--it quickly affirms to others you really have the credit skills your work experience implies. I was very fortunate to stay on with PNC after the merger in 2009, and have been given opportunities to expand my skill set since.

I work hard, but really enjoy the challenge. I never asked, but I expect my CRC gave new management a little added comfort beyond the degrees and resume. The CRC exam is well worth the preparation time for anyone meeting the RMA requirements.


Outliers: The Story of Success
