401(k) Elective Deferral: ^(a) This contract allows for a 401(k) elective deferral of compensation to the Supplemental Retirement Fund by an employee for most classifications that have an employer contribution to the Fund.

LABOR DAY: The Labor Agreement provides for a paid Labor Day holiday which equates to approximately \$.20 per hour for Journeymen. Therefore, the Journeyman total package cost should be increased by \$.20 per hour to determine the true total package cost per hour. See Article V, Section 3 of the Labor Agreement for further explanation.

The Foremen and General Foreman Total Package will increase \$.50 on May 1st, 2021.

The Journeymen Total Package will increase \$2.25 On May 1, 2021.

The current IRS mileage rate is \$.575 per mile.

The Contract expires April 30, 2022.
