| <u>Application Fee</u> : The application fee is a <i>one-time fee</i> as long as you are an " <u>ACTIVE</u> " member of the Space Coast Association of REALTORS®. If you cancel your Association membership and want to rejoin at a later date, you may be required to pay the application fee again. <i>Application Fees are collected at the time of application</i> . |
| <u>Education Passport</u> : Helps you to take advantage of <i>discounted</i> and <i>free</i> classes offered by the Space Coast Association of REALTORS® throughout the year. |

<u>Membership Dues</u>: Membership dues are billed annually, in advance, and are sent to your email address. If your email address changes, please inform the Board. The annual dues bill is sent out in *mid-November*, and the first payment (should you decide to use the payment plan) is due by **December 14**.

Membership Dues for new applicants must be paid at the time of application. ALL DUES ARE NON-REFUNDABLE!

MLS Participation Fee: MLS Participation Fees are ______ per quarter and are pro-rated monthly. You must pay at the time of application for the remainder of the billing period. MLS fees are billed quarterly and sent to your email address. MLS Participation provides you with access to the Multiple Listing Service and all of its benefits. By joining the MLS, you will have an instant inventory of approximately 8,000 active listings and over 10,000 listings that are sold, expired, canceled, or withdrawn.

<u>SUPRA E-KEY (Phone App)</u>: Debit or Credit Card only. <u>CASH NOT ACCEPTED</u>. The Supra E-Key app is available for most cell phones and the download is free. There is a ______ Activation Fee and the monthly fee for Basic Service is _____ plus tax per month.

I understand that membership brings certain privileges and obligations that require compliance, including the following:

I will attend orientation within <u>SIXTY (60) DAYS</u> of joining the Association.

Failure to meet this requirement may result in my REALTOR® membership being terminated.

Membership in the Association necessarily means that I am also a member of the State Association and National Association of REALTORS® and I agree to abide by the Code of Ethics of the National Association, which includes the duty to arbitrate (or to mediate if required by the association), as well as the Constitution, Bylaws, and Rules and Regulations of the Association, the State Association and the National Association. Further, I agree to satisfactorily complete the periodic Code of Ethics training and a reasonable and non-discriminatory written examination on such Code, Constitutions, Bylaws and Rules and Regulations.

I acknowledge that as a member of the Association, I will be licensed to use the REALTOR® trademarks to indicate such membership, and I agree to abide by the rules governing use of those trademarks. I understand that REALTOR® is a federally registered trademark of the National Association and use of this designation is subject to rules promulgated by the National Association. Upon termination of my membership in the Association for any reason, my license to use the term REALTOR® is automatically revoked and I will immediately discontinue use of the term REALTOR® and all REALTOR® trademarks.

Membership is final only upon approval by the Board of Directors and may be revoked should completion of any membership requirement, such as orientation, not be completed within the timeframe established in the Association's bylaws.

In the event of election, I agree to abide by the Code of Ethics of the National Association of REALTORS®, which includes the duty to arbitrate, and the Constitution, Bylaws and Rules and Regulations of the above-named Association, the State Association and the National Association, and if required, I further agree to satisfactorily complete a reasonable and non-discriminatory examination on such Code, Constitutions, Bylaws and Rules and Regulations. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements such as Orientation not be completed within timeframe established in the Association's bylaws. I understand that I will be required to complete periodic Code of Ethics training as specified in the Association's bylaws as a continued condition of membership.

NOTE: The duty to submit to an Ethics Complaint continues in effect even after membership lapses or is terminated. Any ensuing discipline will be held in abeyance until such time as the respondent rejoins an association of REALTORS® (see Code of Ethics and Arbitration Manual, Section 20(e)). The duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while the former member was a REALTOR®.

I hereby certify that the foregoing information furnished by me is true and correct, and I agree that failure to provide complete and accurate information as requested, or any other misstatement of fact, shall be grounds for revocation of my membership if granted. I further agree that, if accepted for membership in the Association, I shall pay the fees and dues as from time to time established. **NOTE:** Payments to the Space Coast Association of REALTORS® are not deductible as charitable contributions. Such payments may, however, be deductible as an ordinary and necessary business expense. **NO REFUNDS.**
