## ***“Sustainable Public Land Management and Balanced Resource Protection for Current and Future Generations”***

As a land and resource stewardship agency that manages over 4 million acres of onshore and offshore public lands and has generated over \$11.8 billion in the over nine decades it has been in service, the California State Lands Commission is committed to responsibly diversifying its leasing and revenue generating portfolio and positioning itself to be a leader in facilitating the state’s clean energy future. The Commission provides the people of California with effective stewardship of the lands, waterways, and resources entrusted to its care based on principles of equity, sustainability, and resiliency, through preservation, restoration, enhancement, responsible economic development, and the promotion of public access. The Commission is excited to work in partnership with all stakeholders to figure out the best path forward to reduce our reliance on fossil fuels, take action to combat climate change, and provide greater opportunities for our desert, forest, and marine ecosystems and energy economies to thrive together through a thoughtful, comprehensive, and equitable transition.

Jennifer Lucchesi will present an overview of the State Lands Commission’s role in the state’s responsible transition from our fossil fuel dependency to a renewable future, including the decommissioning of the last oil and gas platform in state waters in the Santa Barbara Channel and other energy decommissioning projects, the Commission’s renewable energy leasing programs, and efforts to advance offshore wind opportunities.

Jennifer Lucchesi, Executive Officer of the State Lands Commission, has worked for the Commission since November 1999. The Commission appointed Jennifer as its Executive Officer in December 2012. Jennifer graduated with a bachelor’s degree in Agribusiness from California Polytechnic State University, San Luis Obispo. Jennifer began her career at the Commission as a land agent in the Land Management Division, primarily working with ports and harbor districts on waterfront redevelopment efforts. While working in the Land Management Division, Jennifer attended evening classes at the University of the Pacific’s McGeorge School of Law. Jennifer began her legal career at the Commission in 2006 after earning her *Juris Doctor* from the McGeorge School of Law. She worked for the Commission on projects in virtually every county in the state, with an emphasis on land use, resource management, oil and gas decommissioning, waterfront redevelopment, and boundary issues involving ports, harbor districts, and waterways, including title settlements and land exchanges to facilitate redevelopment projects in Chula Vista, Long Beach, Los Angeles, Oakland and San Francisco. Prior to her appointment, Jennifer served as the Commission’s Chief Counsel.
