CEC Leadership Opportunities

On March 7, 2018, the CEC Board of Directors approved Governance revisions, in which our KYCEC Board shared input, resulting in changes to the eligibility, selection process, size and composition of the Board.

- CEC membership will continue to vote on Board positions (not officers), but future CEC Board member nominees and appointments to CEC committees, work groups and task forces will be chosen from a Leadership Development Committee (LDC).
- Leadership candidates will be chosen from this LDC pool of applicants.
- If you are interested in serving in a CEC leadership position, please consider applying for this committee. This year's application deadline is April 11, but this process will be in place moving forward.
