**CHILDREN'S ACTION NETWORK**

**IDEA REAUTHORIZATION NOT  
ACCOMPLISHED DURING  
104TH CONGRESS**

As most of you know, IDEA was not reauthorized during this past Congressional Session. During the last few days of the session, it was apparent that there would be insufficient time for careful and thorough preparation of a final House/Senate bill. Under those circumstances, CEC supported delaying reauthorization until the 105th Congress. There were a few members of Congress who had issues which could not be resolved in a bipartisan manner and to the satisfaction of educators and parents of students with disabilities. Among these issues were cessation of services to students with disabilities who bring a weapon and/or drugs to school and attorney's fees. All of these issues will have to be worked out during the next session.

In the meantime, the good news is that Congress added almost \$800 million to IDEA programs under an omnibus appropriations bill for fiscal year 1997, which started on October 1. The Javits Gifted and Talented Program received an additional \$2 million for a total of \$5 million.

What does this mean? First, it means a lot of work during the next session of Congress. Current federal regulations relating to the education of students with disabilities remain in place. However, IDEA Parts C-H are operating without authorization and are subject to termination unless reauthorized. Parts C-H are discretionary support programs and the early intervention program for birth through two years old. Some of the discretionary programs are the deaf-blind program, regional resource centers, media and captioning service, parent training, clearinghouses, research, etc. Although not reauthorized, all of these programs are funded for next year.

Between now and January, you should continue to remind your member of Congress and Senators Ford and McConnell about the importance of these programs and funding for students and children with disabilities. Members of Congress will be in Kentucky on a more frequent basis in the next few weeks and months. Please take this opportunity to communicate with them on behalf of your students.

We will try to keep you informed as news develops and will suggest actions you might take that could be helpful.

The awards include:

### #1 OUTSTANDING KYCEC TEACHER OF THE YEAR

This award is intended to honor an outstanding classroom teacher or other related specialist. The name of the person selected for this award will be forwarded to International CEC for consideration for the Clarissa Hug Teacher of the Year Award.

**Minimum Criteria:** The nominee should be currently involved in direct teaching, provision of speech, language and hearing or other related services to disabled and/or gifted and talented students. The nominee should have demonstrated exemplary performance over a period of time as a teacher (provider of direct services) involving such qualities as: innovativeness, imagination, creativity, ability to inspire as indicated by clearly recognized achievements perceived by members of the profession and others knowledgeable of the candidate. The nominee must be a KYCEC member in good standing with a minimum tenure of continued membership during the previous five years, and should be an appropriately certified teacher or related specialist as recognized by state and professional authorities.

### #2 MARY MAY WYMAN OUTSTANDING KYCEC MEMBER OF THE YEAR

The purpose of this award is to allow the Kentucky Federation to honor the member who has shown consistently unselfish service in promoting the education and welfare of exceptional children in Kentucky.

**Minimum Criteria:** The nominee must have a minimum tenure of continued membership for the previous three years. The nominee should have contributed to the education and welfare of exceptional children in a number of areas - legislation, recreation, curriculum, etc. The nominee should have devoted much time and effort to the local chapter, subdivision(s), and the Kentucky Federation. The nominee should have provided leadership in the community, with the local school, and with parents.

### #3 CARL PERKINS CONTRIBUTOR TO SPECIAL EDUCATION

This award is to be given to individuals for their distinguished leadership and service in the interest of exceptional children.

**Minimum Criteria:** The nominee need not be working in the field of special education nor be a member of KYCEC. The nominee should have significantly contributed to the education and welfare of exceptional children in Kentucky.

### #4 OUTSTANDING SPECIAL EDUCATION ADMINISTRATOR OF THE YEAR (CEC MEMBER)

This award is to be given to a school administrator whose primary responsibility is special education. The award is for distinguished leadership and support for special education and/or gifted and talented programs in Kentucky.

**Minimum Criteria:** The nominee must be a special education administrator in Kentucky and a CEC member. The nominee must have provided outstanding leadership and developed innovative programming for exceptional individuals.

### #5 OUTSTANDING KENTUCKY STUDENT CEC MEMBER OF THE YEAR

This award will be given to a student CEC member. It is the highest tribute Kentucky CEC pays a student member. The student may be a member of a Kentucky student chapter, regular chapter, or of the Federation.

**Minimum Criteria:** The nominee must be a student member of CEC in Kentucky. The nominee should have demonstrated outstanding service and leadership to the Federation, the chapter and exceptional children in Kentucky. The nominee must be in special education training.

### #6 CERTIFICATES OF APPRECIATION

Each Kentucky CEC chapter or subdivision may submit a name of ONE agency, organization, media network, etc. which has contributed to the advancement of education for exceptional children in the chapter or subdivision. A certificate of appreciation will be signed by the Chapter President and the Federation President and sent to the nominating party. Only ONE certificate nomination from each unit will be accepted.

The Nominations and Elections Committee of the Kentucky Federation of the Council for Exceptional Children extends an invitation to CEC members in good standing to submit a nomination ballot for persons interested in a state office. The following offices are open for next year:

- ◆ **Vice President:** This office carries a four year commitment. The Vice President succeeds to President Elect, President, and Past President. The Vice President conducts the duties of the President in the absence of the President and President Elect, and serves as Editor of the Newsletter. The President Elect chairs the state convention and the Past President is in charge of awards and nominations.
- ◆ **Recording Secretary:** Recording Secretary is elected for a two year term. The Recording Secretary shall be elected in odd numbered years. Powers and duties of the Recording Secretary are to keep records of all meetings of this organization, keep records of all correspondence of the Kentucky Association of SCEC, to carry on such correspondence as directed by the President, Executive Committee, or International Student Governor, and to serve as a member of the Executive Committee.

Persons interested in submitting a nomination should complete the nomination ballot and return it by January 31, 1997. Secret ballot elections will be held during the KYCEC Conference on Friday morning, February 28, 1997. Results will be announced at the Annual Business Meeting. Elected officers will assume their duties on July 1, 1997.
