Society for Vascular Ultrasound Awards and Fellow Elevations at 2013 Annual Conference in San Francisco

LANHAM, MD, June 22, 2013 – During its highly attended 2013 Annual Conference, May 30 – June 1 in San Francisco, the Society for Vascular Ultrasound (SVU) elevated two exemplary members to Fellow. In addition, SVU presented several awards to designate fine service to the organization and to the vascular ultrasound profession. Other awards recognized strong presentations given at the Annual Conference.

FELLOWS

The Fellows Subcommittee, chaired by Vice President David Parlato, made the recommendation to elevate Dr. Steven Leers and Anne Musson to SVU Fellow. The SVU Board concurred with the decision and Steven Leers, MD, RVT, FSVU and Anne Musson, BS, RVT, FSVU were announced as the newest SVU Fellows at the 2013 SVU Annual Conference. David Parlato said this of the Fellows announcement: "SVU Fellowship is the highest membership honor we can bestow on one of our peers, and represents not only distinguished contribution to the field of vascular technology but dedicated leadership and service to our Society. Dr. Leers and Ms. Musson have represented the profession and the SVU estimably over their careers, and the Society is proud to have them join our distinguished ranks as Fellows of the Society for Vascular Ultrasound."

Dr. Steven Leers serves as Associate Professor of Surgery and Medical Director of the UPMC Vascular Laboratories, UPMC Heart and Vascular Institute in Pittsburgh, PA. Dr. Leers' service to SVU includes serving as Course Co-Director of the RPVI refresher course and as the Physician Representative on the SVU Board of Directors.

Ms. Anne Musson serves as the Director of the Vascular Technology Training Program at the Dartmouth-Hitchcock Medical Center in Lebanon, NH. Ms. Musson is also on the Clinical Faculty in the Department of Vascular Ultrasound, College of Health Sciences at Rush University. Anne has been an active member of SVU since its inception in 1977. Anne's SVU service includes formerly serving as eSpectrum Editor and current contributions on the JVU Editorial Review Board.
