### **Rules and Regulations**

1. All SVU members in good standing are eligible to win. All prize winners must have paid dues in full by March 1, 2014.
2. All members are eligible to win. When referring a new member, the following new member categories are excluded: student, transitional, retired or additional members to a current signature lab.
3. All contestants who recruit three new SVU members will be entered into the drawing. To be eligible, the new member must put your name and membership ID number in the referring member box located on the printable and online application. All applications must be submitted by March 31, 2014. Entries that are late, lost, illegible, or incomplete, or are otherwise not in compliance with these official rules will be disqualified.
4. Any SVU member who recruits three new members during the contest period and whose name appears as the "referring member's name" on a new membership application or who submits a mail-in application is eligible to win. For every three people recruited, an additional entry will be entered towards the grand prize drawing. All eligible membership applications must be postmarked by March 31, 2014.
5. If the new member accidentally does not include the referring member's name, the new member will need to contact SVU in writing to request the referring member's name to be added to his/her application.
6. The contest period is June 1, 2013 through March 31, 2014.
7. Contestants agree that the decisions and rules outlined by SVU are final and may not be challenged.
8. Contestants release and hold harmless SVU for its directors, officers, employees, and agents, from any injuries, loss, damage, or liability of any kind arising from or in connection to this campaign or acceptance or use of any prize won.
9. PRIZE: Three (3) prizes will be drawn with one (1) as the grand prize.
