As we look back on the last year, we are incredibly proud to acknowledge the outstanding success we have achieved through our collective advocacy efforts and unwavering commitment to our shared purpose to bring care home. Advocacy is at the heart of our mission, and it is through your tireless efforts that we have made a significant impact in promoting the importance of care in the home. Your dedication to championing the rights and well-being of those in need has not gone unnoticed. Additionally, the private duty nursing sector received a \$46 Million investment and made significant progress in advancing the concept of the paid family caregiver for children with medically fragile conditions.

As we celebrate our success, let us remember that our work is far from over. Medicaid and Medicare funding are always under attack while the population we serve continues to grow. Access to healthcare at home is the solution to escalating health care costs and ensuring our industry is supported during these volatile times will take all of our collective efforts.

MEMBERSHIP

As the pandemic faded, TAHC&H members looked to other challenges on the horizon. From OASIS E to staffing shortages to EVV system changes and more, our members have worked hard to provide so much care with what frequently felt like little support. Despite new providers entering the market, consolidations and closures continued to increase. There are currently 6,698 licensed agencies in Texas. During the past 12 months, there were 235 more new licensed providers in the state, and 112 agencies sold or closed.

TAHC&H has retained an overwhelming majority of its members while recruiting new members despite a home care industry pattern of mergers and acquisitions, agency closures, and a very challenging business and regulatory environment. We continue to reach out to our members through our weekly Perspective, Open Forum, and emails on a wide-range of topics spanning the spectrum of home health and hospice news including up-to-the-minute information. We also traveled to four cities this summer to connect with industry professionals across the state.

We must continue to see growth in all membership categories for us to remain the state's home care and hospice industry's premier provider of resources, education, and advocacy. Working together we can accomplish so much more than alone. TAHC&H thanks our members for choosing to partner with us.



REGULATORY













REGULATORY

A vital benefit of being a TAHC&H member is access to our Regulatory team, who creates a secure, supportive environment for TAHC&H members to ask questions and seek help with significant issues impacting their agencies.

In 2022-2023, our regulatory team provided real-time guidance and resolution to provider's state and federal regulatory issues. From the end of the COVID-19 public health emergency to licensing to re-credentialing

and revalidation issues to working with payer sources to assist providers with contract, and much more, our team worked hard to support the home health and hospice industry in Texas.

Since TAHC&Hs 2022 annual report, the TAHC&H Regulatory staff have resolved hundreds of regulatory inquiries with the top subjects being:

- Continuous changes in COVID-19 related guidance through the end of the pandemic and post-pandemic (OSHA, CMS, HHSC, EEOC, CDC, etc.)
- End of Medicaid Continuous Enrollment
- Electronic Visit Verification
- Implementation of the HHSC Critical Incident Management System (CIMS)
- CNA/MA Certification Transition to TULIP
- ARPA Funding (submitting reports and attestation, compliance list, overall process)
- Ongoing Staffing Shortage Issues
- HHSC Hospice Contracting Issues
- CMS, TMHP, OSHA Investigations, DPS

- Audits, and HHSC Surveys
- CMS Hospice UPIC Audits
- Palmetto/CMS Review Choice Demonstration (process, non-affirmations, and ADR)
- TMHP/MCO Claims Denial and Contract Issues
- OASIS, Documentation, and Billing Issues
- Palmetto/CMS Claims Payment Issues
- Unjust UPIC/ADR/Recoupment Issues from all payer sources
- HHSC TULIP/Licensing Issues
- Stock Transfers and CHOWs
- TMHP Revalidation Issues

TAHC&H regulatory staff and TAHC&H members also work hard on overall policy issues with our State Agency and Legislators. This includes drafting TAHC&H's initial comments to proposed rules that are published by both federal and state regulatory authorities.



2022-2023 REGULATORY WINS

TAHC&H Regulatory also continues to work for members by facilitating meetings with HHSC, DSHS, TMHP, OSHA, Palmetto and CMS to resolve industry concerns and member issues, submitting comments on State and Federal regulations, and by involvement in various HHSC workgroups and Advisory Committees. This year, regulatory staff assisted TAHC&H members on priorities related to the end of the public health emergency, educating on the consistently changing guidance and proposed rules issued by the different state and federal agencies, worked diligently on priorities related to claims denial and recoupment issues with multiple payer sources; worked with providers and HHSC on significant licensing issues, including CHOWS, stock transfers, late renewals, and revocations; Assisted providers with ADR/UPIC Review/MCO and medical review and appeals processes; and educated and assisted providers on the ARPA funding, the EVV Transition, the End of Medicaid Continuous Enrollment, as well as multiple system issues and glitches with eServices, PEMS, TULIP, and more. Wins include:

- Assisting providers with significant licensing, enrollment, contracting, and revalidation issues;
- Working directly with payer sources, UPIC, and multiple regulatory authorities to assist providers with contract and claims payment issues, including reversal of denials and unjustified recoupments;
- Connecting providers to regulatory bodies through various virtual platforms to ensure they have the ability to get real time assistance and resolution for their issues;
- Advocating, on behalf of the home care and hospice industry, by supplying comments
 and feedback to regulatory authorities regarding proposed rule sets, continuously
 pushing for change in pending guidance and pushing for updates to outdated
 regulations, as well as continuing to push for more detailed guidance in the form of
 interpretive guidelines to current regulations.
- Providing ongoing, real-time guidance during the ongoing and end of the COVID-19 public health emergency.





















GOVERNMENT AFFAIRS













GOVERNMENT AFFAIRS REPORT

This Legislative Session, the Texas Association for Home Care & Hospice set out with an ambitious agenda to change the state of home care and hospice in Texas.

BUDGET

TAHC&H aimed to educate legislatures about our industry's complicated payment rates. We worked hard to secure funding increases for community care, private duty nursing and pediatric therapy (see table to right). TAHC&H members traveled from across the state to join us on hearing days, where we would often wait for hours to give testimony. We held dozens of meetings with legislators in both Chambers and partnered with champions who carried our riders including Rep. Donna Howard, Rep. Steve Allison, Sen. Charles Perry, and Sen. Judith Zaffirini.

While there were some disappointments this session, the legislature made a nearly \$2 billion (\$800 million GR) investment in community care, and with continued teamwork and grit, we believe we can continue to move the needle forward in future sessions.

Investments made in the 88th Legislative Session

Community Care	\$2 Billion (\$800 million GR) \$10.60 Base Rate with no service supports.

ADVOCACY & LOBBY DAY

In addition to our members who regularly traveled to give testimony, TAHC&H members also took part in several advocacy opportunities with TAHC&H. We had record turnout of 150+ members for our Lobby Day at the State Capitol in February, and we also held a Joint Advocacy Briefing in January with local nonprofits, advocacy groups, and members from the Texas Workforce Commission. We also want to acknowledge our members who could not travel to Austin but wrote or called their representatives through our Action Alerts; an astounding 5341 state actions were taken by members and home care professionals across the state this session!

LEGISLATION

TAHC&H tracked just shy of 300 bills this session. Here are a few pieces of legislation that passed which will impact home care and hospice:

- 1. HB 44, prohibits discrimination based on immunization status
- 2. **HB 81**, the Texas COVID19 Vaccine Freedom Act
- 3. **HB 609**, protects businesses from liability arising from exposure to a pandemic disease
- 4. HB 728, created an interagency coordinating council for aging
- 5. **HB 1099**, requires criminal history checks for residential caregivers
- HB 1755. created the Lone Star Workforce of the Future Fund
- 7. **HB 2727,** amends "home telemonitoring service" to include remote health data monitoring provided by rural health clinics and federally qualified health centers.
- 8. HB 3162, the Texas Advanced Directive Act
- 9. HB 4696, a list of new reporting requirements for ANE
- 10. SB 25, creates a new scholarship program for nursing students
- 11. SB 29, prohibits vaccine and mask mandates
- 12. SB 240, requires facilities to create a workplace violence prevention committee
- 13. SB 401, prohibits price gouging for nursing during a public health emergency
- 14. SB 739, designates October 10 as Supportive Palliative Care Awareness Day

TAHC&H also fought hard for three bills that ran out of time this session. These are important issues which we will continue to advocate for in future sessions:

FEDERAL ADVOCACY

TAHC&H continues to work with the Texas Congressional Delegation and the Biden-Harris Administration to ensure patients have access to medically necessary care in the home. To best share our message at the national level, TAHC&H organized two trips to Washington, D.C. for critical in-person meetings with Legislators and staff. In



September 2022, TAHC&H hosted a D.C. Fly-in with 11 TAHC&H members in attendance to visit with 17 offices. In March 2023, TAHC&H arranged for our annual March on Washington with 18 TAHC&H members joining together to visit 23 congressional members and their staff. TAHC&H federal priorities this year included:

- Ensuring appropriate and adequate reimbursement for Medicare home health services and hospice by preventing additional reductions to the home health benefit
- Supporting a well-qualified and reliable home care workforce through recruitment and retention policies that ensure that health care providers can address workforce challenges to meet the needs of patients and the rising demand for care in the home
- Increase telehealth flexibility in the home health benefit ensuring adequate reimbursement policies after the conclusion of the public health emergency





