#### 1. Membership:

- 3227 members (2991 active, 6 honorary, 32 international, 34 retired, 151 student)
- Letters from Chair were sent out to all members
- We had 892 new members and 781 non-renewing members
- Survey results from non-renewing members
  - non-renewing members were either changing jobs and no longer working in nutrition support or they did not feel that they could afford/wanted to pay for Academy dues combined with DPG dues
- We had 7 institutional *Support Line* subscriptions
- Member survey completed January 2015 reviewed/discussed at June retreat. Overall theme was that members are seeking education/information on nutrition focused physical assessment, managing parenteral nutrition, placing feeding tubes, and indirect calorimety. Discussed where to incorporate these topics including webinars, symposiums, and products.

# Support Line

- Published 6 issues of Support Line under the direction of Kate Willcutts,
   Editor
- Associate Editors included Kelly Kennare, Britta Brown, Deb Carpenter (continuing education), and Rebecca Brody (Writer's Mentoring Program Chair)
- Several Guest Editors assisted with planning including Sarah Peterson,
   Stephanie Dobak, and Kris Mogensen
- 2 issues were provided electronically only (member survey indicated that members were ok with moving to some issues being electronic only); the other 4 issues were available electronically and in print/mail. Unique downloads of Support Line doubled with the electronic issues of Support Line
- Each issue offers 3 CPE credits by completion of a quiz on the DNS website

# Career Mentoring Program

- The DNS DPG Career Mentoring Program is a robust member benefit designed to link members with at least 4-5 years nutrition support experience with other members who are seeking career guidance and/or support in learning advanced skills in clinical nutrition.
- 15 volunteer mentors had been matched to 19 mentees. Goals vary among participants and include, but not limited to, the following: 1)
   Enhance knowledge of nutrition support; 2) Increase professional network;
   3) Improve assessment skills when caring for patients with a variety of comorbid conditions; 4) More effectively utilize current evidence-based practice guidelines and protocols

# Writer's Mentoring Program

- The Writer's Mentoring Program pairs experienced authors with mentees who are interested in writing for publication but haven't published before. Articles are submitted to *Support Line* and go through the peer review process. Mentors help mentees through the entire process.
- 2 mentees have been matched with mentors and are currently working on articles

#### Website

- DNS has a robust team of volunteers to help with website content. Last year we had 29 total volunteers focused in several different content areas: transplant (3), critical care (4), GI (4), pediatric/neonatal (8), research (4), homecare (4), student (1), general (1).
- Volunteers post a summary of a current research article every other month
- All DNS leaders had a week to monitor our forum content including responding to posts/questions from members
- DNS leader e-mail addresses were added so that they have @dnsdpg.org. For example, you can contact the Chair by e-mailing <u>chair@dnsdpg.org</u>. The e-mail addresses were set up to be automatically forwarded to an e-mail address that the volunteer monitors regularly.
- The website committee added new sections to the website this year including a resource library, student forum, and student network.

#### Webstore

- This was the first full year of the DNS Webstore. The Store was upgraded to allow for webinar sales as well as CPE quizzes/certificates for nonmembers (non-members pay higher fees)

# 3. Professional Development:

# 2015 Symposium

- Hosted the 2015 DNS Symposium: Building on the Best: Integrating Evidence, Research, and Skills Into Your Practice.

- Symposium was held June 12-13, 2015 at the Embassy Suites, Inner Harbor in Baltimore, MD
- Topics covered included: Underfeeding in the ICU, address hospital
  malnutrition, applying the pediatric malnutrition definition, fluid balance in
  the enterally fed patient, iron deficiency anemia, social media, functional
  assessment, lean body mass assessment, muscle and fat mass
  assessment, critical care guidelines, enteral connectors, probiotics and
  FODMAPs, parenteral lipid formulations, outcomes research,
  micronutrient assessment, abdominal and edema assessment, abdominal
  radiographs
- Most symposium sessions were recorded and are available for purchase through the link on the Webstore
- There were 65 registered attendees for the symposium (not including speakers, sponsors, and leadership)
- Executive committee discussed at length the number of attendees, evaluations, budget and expenses (symposium was over budget). It was decided to continue offering a symposium every other year and to reassess outcomes of the next symposium

- Held an evening member reception which was well attended

#### **CNM DPG Annual Meeting**

- Submitted a proposal for Gail Cresci to speak about IRB and grant writing at the CNM annual meeting. Proposal was accepted.

# Pre-Conference Skills Workshop at Clinical Nutrition Week

 Hosted a pre-conference workshop at CNW 2016 in Austin, Texas. The workshop was a full-day course that covered all aspects of nutrition focused physical exam.

- Chair-Elect submitted 3 proposed sessions for FNCE® 2016 in Boston,
   MA. Sessions were as follows:

  - Navigating the Seas: Hydration, Electrolytes, and Acid-Base.
     Speakers: Kathleen Gura, PharmD, BCNSP, FASHP, FPPAG, FASPEN and Elizabeth Pash, MS, RD, CNSC
  - Developing a Hunger for Malnutrition: Engaging Hospital Administration. Speakers: Cindy Hamilton, MS, RD, CNSC and Art Thompson, Administrator, Digestive Disease Institute
- All 3 above session proposals were accepted
- Director of Professional and Product Development proposed a 4-hour Nutrition Focused Physical Assessment pre-conference workshop. The proposal was declined

#### Webinars

- Several webinar volunteers assisted in planning and executing 4 webinars over the year: Malissa Warren (chair), Colleen Tsarnas, Ronelle Mitchell, and Debbie Konrad
- There were several challenges this year with webinars related to the platform used and registration through our website/webstore.
- Hosted 4 webinars:
  - The Ketogenic Diet presented by Kelly Roehl on November 12, 2015 was offered complimentary (583 attendees)
  - TPN for the Neonate presented by Colleen Tsarnas was recorded and is available on the Webstore
  - TPN Order Writing for the Adult presented by Mandy Corrigan and Elizabeth Pash on March 17, 2016 (106 attendees)
  - Managing the Non Adherent Patient on Home PN presented by Sandy Austhof and Jamie Davilla on May 26, 2016
- This year we began charging for webinars and had many discussions regarding pricing structure. After assessing what other DPG's and organizations offer, we decided on a pricing structure as follows:

# Item Writing

- Trained 2 new item writers in the Fall of 2015 Andrea Jevenn and Arlene Escuro attended 2 separate training session on item writing. They join Lindsay Dowhan, Stephanie Dobak, and Debbie Carpenter (Item Writing Chair). New item writers that receive training funded by DNS are asked to commit to at least 2 years on the committee
- Accomplishments include item writing questions for:
  - Developed and reviewed 5 post-test questions for all 11 presentations recorded from the symposium
  - Reviewed/edited questions for each article published in Support Line
  - Developed and reviewed 5 questions for each webinar that was over 1 year old

# 4. Existing Products:

#### Malnutrition Physical Exam Flash Drive

In late Spring 2014, DNS and the Cleveland Clinic entered into a collaborative relationship to market and offer a Malnutrition Focused Physical Assessment video. The video is a 15-minute example of how to conduct a physical assessment focused on malnutrition. The video is available on a flash drive and orders are fulfilled by our Material Manager (Marion Winkler). As of May 10, 2016, 186 flash drives have been purchased.

#### Enteral and Parenteral Slide Sets

The newly revised enteral and parenteral slide sets are available on the Webstore for purchase and download. As of May 2016, we have sold 2 enteral slide sets, 2 parenteral slide sets, and 19 combined packages of both slide sets

#### 5. New Projects/Products:

#### Nutrition Focused Physical Assessment Video

- A committee has formed and met throughout the year to develop a revised nutrition focused physical assessment video. Committee members include Ainsley Malone, Beth Taylor, Susan Brantley, Peggy Hipskind, Carol Ireton-Jones, Sarah Peterson, Malissa Warren, and Jane Ziegler.
- Accomplishments for the 2015-2016 year were:
  - Confirmed filming capability for the video at Barnes Jewish Hospital
  - Hired a Project Manager to manage the project
  - Identified an RD that can narrate the video
  - Finalized scripts for the video
- This project is supported by a \$20,000 educational grant from Nestle awarded the previous year

#### Feeding Tube Placement Toolkit

- A member survey conducted in early Spring 2015 (March-April) showed that members were interested in learning about how to place feeding tubes
- A committee was formed to begin discussing development of a feeding tube toolkit with the intent of providing a starting point for RDs that may be interested in placing feeding tubes. Christina Rollins was identified as Chair of the committee.
- Committee has submitted proposed budget, communicated with the Academy regarding references on regulations by state, identified authors, designed a template, and secured professional editing services
- Goal completion date is May 2017

#### Malnutrition Project

 Malnutrition continues to be a challenge in hospitalized patients with at least 1 and 3 patients meeting criteria for malnutrition. Unfortunately, few hospitals have been able to identify, document, and properly code for malnutrition

- We applied for and received a \$20,000 unrestricted educational grant from Baxter to develop educational programs on the topic of malnutrition and coding
- The funding will be used to hire a project manager, develop webinars, devote an issue of Support Line to this topic and develop a downloadable presentation slide set on malnutrition identification and coding that RDs could use when speaking with Administrators
- Developed a survey of DNS members regarding current practice in diagnosing malnutrition and coding for malnutrition via SurveyMonkey.
   Survey results will help to identify areas to focus our educational outreach.

# Advanced Practice Residency (APR)

- The APR committee consisting of Mary Marian, Susan Roberts, Cindy Hamilton, and Lauren Melnick finalized the APR application
- The Executive Committee reviewed and approved the application to ACEND to start an Advanced Practice Residency in nutrition support
- The application was submitted in late 2015 and DNS was notified that the program was not approved. ACEND provided feedback and the APR committee is reviewing and addressing all of the feedback received with the goal of resubmitting the application by the end of December 2016

#### Short Bowel Education Series

 DNS was contacted by MedScape to collaborate on a series of educational programs about Short Bowel Syndrome. MedScape is waiting to hear back about grant funding prior to completing the development of the programs
