

Diversity and Inclusion: Our DPG has continued to support an atmosphere of diversity and inclusion, recognizing the disproportionate effect the pandemic has had on people of color and the significant racial inequalities and health disparities in our country. A round table discussion on implicit bias and other factors that contribute to health disparities in communities of color was held for our members. Our Diversity Liaison, Shamera Robinson, MPH, RDN, partnered with National Organization



of Blacks in Dietetics and Nutrition (NOBIDAN), to offer an outstanding webinar, *Diabetes Throughout the African Diaspora*. Our delegate, Jennifer Barr, MPH, RDN, LDN, CDCES, partnering with Shamera, facilitated book club discussions focusing on bringing together four core components of cultural awareness and humility: openness, respect, curiosity, and accountability. We are proud of the initiatives our Practice Group has taken, but we recognize there is more work to be done.

The Professional Development Committee develops professional skill building activities for the Diabetes Dietetic Practice Group members related to research, education and practice. DDPG was able to offer members nine webinars free of charge in 2020-2021. Webinars provide 1 CPEU and are available to view on demand. Webinars are an easy way to stay up to date on the latest in diabetes care and are a valuable resource to our members.

The DDPG website was updated monthly with current journal articles for members in the area of pre-diabetes, type 1 diabetes, type 2 diabetes and gestational diabetes. The technology section of the DPG website was updated with information on oral medications, insulin, incretin mimetics, insulin pumps, continuous glucose monitors and blood glucose meters. Members were also kept up to date on industry news and recalls.



The first virtual symposium was held on February 19th and 20th and provided members with 8 CPEUs. Topics included technology and CGM, intensifying nutrition intervention, medication adherence, and multicultural counseling. Members could access presentations as on-demand

recordings for three months post event. Each day also included a case study which was discussed by the speakers. It was a great success!

POLICY AND ADVOCACY Amanda Kirpitch, MA, RDN, CDCES, CDN



As the Policy and Advocacy Leader, my job is to represent the Diabetes Practice Group on legislative issues to the Academy of Nutrition and Dietetics and other relevant organizations and bring the current issues, concerns, and pertinent advocacy issues to our membership so as an organization we can all be effective policy advocates. This year at least seven Action Alerts including the MNT Act and Medicare Payment cuts were sent to members. Our Committee provides comments and review on healthcare policies, and attend meetings of relevant groups like the Diabetes Advocacy Alliance to keep abreast of legislative changes in the policy space. This year the MNT Act Advocacy Day was held virtually where we spoke with Senate and House staff on voting in favor of this important nutrition legislation.

INCLUSION, DIVERSITY, EQUITY AND ACCESS

Given the rise in civil unrest and health inequities, the diversity liaison partnered with leaders across Diabetes DPG to host conversations about racism, discrimination, implicit bias, and other factors that determine if all persons with diabetes are able to receive high quality care and education.

Our diversity liaison facilitated an intimate roundtable discussion focused on racism and implicit bias. The roundtable was co-led by Constance Brown-Riggs, MSEd, RD, CDCES, CDN and Sue Ellen Anderson-Haynes, MS RDN CDCES LDN, NASM-CPT and allowed 25 members to kindly explore and challenge their norms in a safe environment.

Conversations also included an exploration of cultural foodways for over 300 members attending a webinar. The DDPG diversity liaison worked with NOBIDAN to host a webinar highlighting cultural phrases, food norms, preferences, and community-specific factors that impact diabetes care in Black communities.

Diabetes DPG was selected for a 2021 Diversity and Inclusion (D&I) Mini-grant to support our book club. The Diabetes DPG book club, a collaboration between the diversity liaison and DPG delegate, helps center conversation on cultural humility, health equity within nutrition, and translation to clinical practice. The initial book club discussion focused on *Stamped: Racism, Antiracism, and You* by Jason Reynolds and Ibram X. Kendi followed by *A Practice Beyond Cultural Humility: How Clinicians Can Work More Effectively In A Diverse World*.
