

#### **Member Communications**

Four Future Dimensions in Clinical Nutrition Practice <u>newsletters</u> were published and posted to our website, <a href="https://www.cnmdpg.org">https://www.cnmdpg.org</a>. Topics included volume based feeding protocol, tracking patient outcomes, injectable emulsions, implementing a malnutrition coding program, maximizing outpatient clinical nutrition services, caring for transgender and gender diverse patients, malnutrition prevention in ambulatory settings, and important research activities. Regular reports kept members informed from public policy, the House of Delegates, nutrition informatics, pediatrics and quality subunits, reimbursement, professional development activities.

New this year, in addition to the full newsletter posting, each featured article within the newsletter was posted separately. Previously a separate document was updated to log publication titles and dates and required cross-referencing to locate past articles. This change enabled readers to easily locate and download article titles with CPE and find their desired subjects as well as downloading the full newsletter. A total of 227 members completed one (or more) of 16 available guizzes with a 73.6% successful pass rate.

A new Communications Coordination Committee and added chair and website reviewer positions were approved by the Executive Committee to help coordinate member outreach on social media, communicate DPG and Academy messaging and expand our reach to attract new members and maintain current website information. There was a significant increase (28%) in social media postings and member participation in 14 months.

Symposiums in both 2018 and 2019 met expenses, so this focus greatly assisted in that accomplishment. Other areas to increase membership and communications included reorganizing the website contact page, updating bios, assuring all photos were present, and a Symposium and FNCE® promotional gift that included all the social media naming conventions. ## **Public Policy**

CNM DPG participated in multiple Academy Action Alerts, and through May of 2018 had an average of 4.62%, CNM DPG was above the average for all Action Alerts except one. CNM Members contributed 7.35% to ANDPAC which is close to the Academy average contribution. The committee worked diligently to communicate to members and added more social media activity. This was especially effective in communicating the excitement and energy for the Public

Policy Workshop in Washington DC, immediately after FNCE®.

The PPW18 focus was Malnutrition and CNM DPG members were very active in the event, with nearly 50 members registering for PPW. Complete records of the committee activities are also recorded in the newsletters.



CNM DPG through the Academy relationship, also supported Malnutrition Awareness Week 2018, with social media communications.

#### **Reimbursement Committee**

The Reimbursement Committee continued to support member needs and helping with Action Alerts and communications on the complex topic of Reimbursement. A webinar, "Reimbursement: Endless Possibilities", is scheduled for August 2019.

A proposal was forwarded by the committee, and agreed to by the EC, to develop a reference for outpatient nutrition services that members can use as a guide to navigate the complex outpatient reimbursement and regulatory system and to pull together existing useful information into one publication. The guide "Pocket Guide for Outpatient RDNs" is moving along very well within the Academy structure and work will continue into the next fiscal year.

#### House of Delegates

CNM Delegate, Young Hee Kim again provided updates to CNM members and sought member feedback on the House of Delegates mega issues, as well as representing CNM interests at the Academy House of Delegates. Reports of the activities and requests for feedback were included in each newsletter and as appropriate for social media to members. The Fall 2018 topic was about restructuring the House of Delegates to better meet the needs of our profession in the second century. The Spring 2019 topic was held virtually on the topic of *Consumer Awareness and Changing Drivers of Food Choices*.

#### Informatics Sub-Unit

The Informatics Sub-Unit continued with much activity and involvement in Academy activities. The Sub-Unit Chair was final reviewer for the Academy Informatics Position Paper that is to be published in the Journal of the Academy of Nutrition and Dietetics' <u>August 2019 issue</u>.

The Informatics Sub-Unit was reorganized such that it now reports to the Past Chair. Social Media and the EML were moved from the Sub-Unit to the New Communications Coordination Committee. This enables the Informatics Committee to focus on informatics more directly and the coordination and oversight of the many and diverse member communications to be better aligned with their intended function.

The Sub-Unit also actively contributed to various requests for input to the Academy on informatics related topics and hosted an Informatics Roundtable discussion at the Symposium. CNM members participated in the Genius Zone at FNCE®18. CNM provided slides highlighting the Informatics Sub-Unit and CNM Social Media for the slide deck.


A new Informatics DPG is formed and the CNM DPG Sub-Unit will continue to liaison with the Nutrition Informatics DPG in the future.

#### **Quality Management and Process Improvement Sub-Unit**


The QPI Sub-Unit undertook a major project to coordinate with the Academy to update the clinical nutrition management standards of professional performance. The CNM DPG Plan of Work included funding of this expensive undertaking within the Academy designated process. CNM DPG also participated and supplied insight and information prior to submission. The *Revised 2018 Standards of Professional Performance for Registered Dietitian Nutritionists (Competent, Proficient, and Expert) in Clinical Nutrition Management,* with significant updates to recognize current practice, was published in the Journal of the Academy of Nutrition and Dietetics and is available <a href="here">here</a>. Thank you to the QPI Sub-Unit and the authors and reviewers for this significant contribution.

The CNM DPG Symposium, for the 5<sup>th</sup> year, included Quality Improvement posters with awards and recognition. This project is a major undertaking for the committee, and has been very successful and engaging for members.

The 2019 QPI winner was Karen Jasso from Children's Health in Dallas Texas and her project titled "Engaging Dietitians to Increase their Patient Productivity through a Shared Goal." This award is based on reviews and blinded voting of the submissions, with ten QPI Projects selected for the Poster Session at the Symposium. The 2019 Runner up was Tina Boucher-Reilly from Hebrew Senior Life in Roslindale, MA. Her poster was titled "Malnutrition Assessment and Diagnosis." During the Symposium, attendees also vote for their favorite Poster. This year the People's Choice Award went to Angela Lago, "Bridging the Gap from Hospital to Home: Implementation of a Malnutrition Transitions of Care Program."

#### Pediatric Management Sub-Unit



The Pediatrics Subunit completed a Staffing Survey of Pediatric hospitals to better understand the needs and concerns of pediatric acute care dietitians in various clinical settings. They also received sponsorship for two in-person meetings, one at each FNCE® and Symposium to help attendees understand the results of the survey. The CNM Peds staffing and productivity benchmarking survey results were posted on the CNM Pediatric Sub-Unit EML.

The Pediatric Management Sub-Unit has its own EML (CNMPeds) as well as a <u>webpage</u> on the CNM website with a growing number of categories as we add information. Co-chairs Caroline Steel (R) and Deb Hutsler hosted the group meeting at Symposium.

The Nominating Committee offered an excellent slate of candidates for our 2019-2020 Ballot, and continue to recruit CNM members who are interested in getting more actively involved in CNM DPG.

#### **Executive Committee Activities**

The Executive Committee accomplished much to move the DPG forward:

- The EC held eight meetings. Six 1.5 hour conference calls and two in-person meetings. With in-person held at the FNCE®, October 2018 and at Symposium, May 2019.
- CNM DPG Guiding Principles were updated from 2011 forward. The document was shortened from 100 to about 40 pages.
- Added Diversity Liaison position, and a "Diversity and Inclusion Thought Bite" was included in the Newsletter to help communicate to members.
- CNM continued with a contract with Internet Tools, Inc. to support the Electronic Mailing list (EML) and An Apple a Day, LLC, for administrative support services, with the website.
- The Sponsorship prospectus was refined with more opportunities and details appealing to potential sponsors and aligned with Academy policies. The timeline for sponsorship commitments was moved to help with planning and provide enough time for completion before Symposium and FNCE® activities.
- The organization chart was updated with the addition of a Communications Committee, and for movement of Social Media and the electronic List Serve to the Communications committee from the Informatics Sub-Unit. The Informatics Sub-Unit moved under the Past Chair.
- The timeline for Symposium speaker applications, registration, exhibits was adjusted to better enable attendance, and support preparation.
- Supported funding to be represented at the House of Delegates meeting at FNCE® and the Public Policy Workshop targeting malnutrition.
- Guests at in-person CNM DPG Executive Committee Meetings included:

- Representatives promoting the role of Nutrition and Dietetic Technician,
   Registered. Subsequently the link to this information was added to the CNM DPG
   Website.
- Representatives from the Nutrition Research Network discussing the Malnutrition
   Clinical Characteristics Validation and Staffing Study.
- FNCE®2019 Spotlight session was accepted, *Influencing Leadership and Inspiring Change at Every Career Stage*, to be presented by Caroline Steele and Wendy Phillips.
- CNM DPG Member Reception at FNCE® with over 75 attending with appreciated Sponsorship from Abbott.
- Operational and Financial activities included:
  - Funding for the CNM DPG Standards of Profession Performance for Registered Dietitian Nutritionists (Competent, Proficient, and Expert) in Clinical Nutrition Management to support the writing and review process, to be published Fall 2019.
  - Plan of Work included modifications to reduce expenses and more opportunities for sponsorship for EC meetings and attendance at FNCE® and Symposium.
  - CNM DPG was unable to update the website as planned, due to Academy updating the Academy website. Funding had been set aside in the POW for website update in FY 2018 and 2019, but was not able to be completed pending Academy actions and timing.

#### **Foundation Activities**

CNM DPG EC Approved purchase of 6 "Bricks" for the "Buy a Brick, Build the Pathway to Nutrition Policy Goals" at FNCE® from ANDPAC. The bricks were part of a larger brick walkway on display at FNCE® 2018 in Washington DC.

The FNCE® Foundation Auction CNM Donation was "Tools for the FUN Nutrition Professional on the Go!". The donation was a JBL 4 Waterproof Bluetooth Portable Speaker, with a waterproof case, and JLab Wireless Over-ear Bluetooth headphones. The donation added almost \$200 to the Foundation fundraising effort.

CNM DPG sponsored a student attendee from Puerto Rico at FNCE® with a \$100 stipend to help offset expenses.

CNM donated an additional \$11,000 to the Foundation.

#### **Fundraising Committee**

The CNM DPG Sponsorship Prospectus was updated to reflect more useful timelines and structure to support both interest by potential sponsors and organization for CNM DPG activities. An important factor was significantly more lead-time for potential sponsors and defined deadlines. Sponsorship according to Academy guidelines helped greatly in moving the CNM DPG Strategic Plan forward. CNM DPG thanks our sponsors for their various contributions to our 2018-2019 activities.

#### **Research Committee**




